[From the Nashville Banner, 22.] We have received the full particulars of the robbery of the bank of Messrs. N. L. Long & Co., at Russellville, Tenn., on Friday, about ten days ago. The bank was closed for a few days, and the amount of the robbery was five hundred dollars.

Mr. Long took the precaution to ask his name and address of each of the robbers, and the names of the robbers were as follows: Thomas A. Colburn, who lived in the city of Louisville; one of the coupons on the bond had been cut off and when, in reply to an inquiry as to what he would do for it, Colburn (we call him such for convenience sake) said he would sell it at par, with the secured interest added.
