ACT OF INCORPORATION OF THE NATIONAL REFRIGERATOR & FIXTURE CO.

UNITED STATES OF AMERICA, STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS.

Be it known, that on this twenty-eighth day of the month of January in the year of our Lord, one thousand nine hundred and thirteen and the independence of the United States of America the one hundred and thirty-seventh, before me, Emile Pomes, a notary public, duly commissioned and qualified, in and for this city and the parish of Orleans, and in the presence of the witnesses hereinafter named and undersigned, personally came and appeared the several persons named and designated, who declared that availing themselves of the provisions of the laws of this state relative to the organization of corporations, and particularly to Act No. 78 of the General Assembly of the state of Louisiana, for the session of 1904, they have covenanted and agreed, as well as such other persons as may hereinafter join or become associated with them into a corporation and body politic in law, for the objects and purposes, and under the agreements and stipulations following, to-wit:

ARTICLE I.

The name and title of this corporation shall be the "National Refrigerator & Fixture Company," and under its legal name it shall have and enjoy all the rights and privileges granted by law to corporations. It shall exist for a period of ninety-nine years from the date of its incorporation in this state, or elsewhere, drilling out, locating and maintaining oil, gas or any other minerals from the earth, and for the housing, preservation, handling, refining and transportation of such products as are extracted, and particularly storage tanks and pipe lines, all solely for the use of its own business and without power of eminent domain to buy, sell or otherwise acquire and alienate, and to establish, export or import oil, minerals or mineral products of all kinds and in connection with the objects and purposes hereinbefore set forth, to locate and maintain warehouses, sheds, storage tanks, tank cars, dwellings, store-houses and repair shops, to sell merchandise and carry on a general store and commissary, and to conduct hotels, boarding houses and lodgings for transient guests and employes, and generally to hold and exercise all such incidental powers and privileges not expressly excluded as relate to the objects hereinbefore set forth.

ARTICLE II.

The domicile of this corporation shall be in the city of New Orleans, Parish of Orleans, State of Louisiana, and all citations or other legal process shall be served upon the president of said corporation, or in case of his absence, upon the vice-president, or, in the absence of both of the officers, upon the secretary of the corporation.

ARTICLE III.

The objects and purposes for which this corporation is established and the nature of the business to be carried on by it are declared and specified to be to purchase, own, hold, sell, mortgage, lease, alienate, receive and otherwise acquire and dispose of real estate, oil and mineral land and oil and mineral rights and any other interest in lands, to locate and maintain warehouses, sheds, storage tanks, tank cars, dwellings, store-houses and repair shops, to sell merchandise and carry on a general store and commissary, and to conduct hotels, boarding houses and lodgings for transient guests and employes, and generally to hold and exercise all such incidental powers and privileges not expressly excluded as relate to the objects hereinbefore set forth.

ARTICLE IV.

The capital stock of this corporation is hereby fixed at six thousand dollars (\$6,000.00), divided into and represented by one hundred and twenty (120) shares of fifty dollars (\$50.00) each. The whole amount of said stock or any part thereof may be issued and delivered to any person, firm or corporation for the acquisition of rights, privileges, franchises and property purchase and acquired by this corporation, also in payment, settlement and adjustment of the costs, fees, charges and expenses and share commission incurred for services rendered in the formation and organization of this corporation, and in acquiring and installing the same, and also for cash or in installments of such amounts as the board of directors may determine, the value of the shares to be received or services actually rendered to this company. The board of directors of this corporation is especially authorized to dispose of the stock of this company in whole or in part, for any and all of the purposes above stated, as in its judgment may seem fair and proper. This company shall begin business as soon as three thousand dollars (\$3,000.00) of its stock shall have been subscribed.

ARTICLE V.

All the powers of this corporation shall be vested in and exercised by the board of directors, composed of five (5) stockholders, any three of whom shall constitute a quorum for the transaction of business. The said board of directors shall be elected by ballot at the first meeting of the corporation, to be held on the first Wednesday in January of each year. The first election to be held in the year 1914.

All elections shall be by ballot, and the board of directors shall have the supervision of three (3) commissioners to be appointed by the board of directors, and, in the absence of any commissioner, the president shall have the power to fill the place by appointment, and of all such elections as well as meetings of the board of directors, or for liquidation or dissolution, or as otherwise required by law, ten (10) days notice shall be given by mailing to each stockholder a copy of the notice upon the books of the company, at his last designated address or to the General Delivery at New Orleans, or by personal delivery to the address of each stockholder, and by an announcement stating the time and the place of the meeting. Each shareholder shall be entitled to one vote for each share of stock standing in his name on the books of the company, cast in person or by proxy, and the majority of the votes cast shall elect the board of directors, who shall have the power to fill all vacancies that may occur on the board. Failure to elect directors on the day above specified shall constitute the corporation, but the directors then in office shall remain in office until their successors are elected and qualified.

The notice of another election shall forthwith be given, as above provided. Such notice of election shall be continued to be given until an election is held. The board of directors at the first meeting following an annual election shall elect from their number a president and vice-president, a secretary and a treasurer, all of whom shall be stockholders, and such other officers as the board shall deem necessary. The board shall have the power to make and establish such rules and regulations as may be necessary and proper for the support and management of the business of this corporation, and not inconsistent with the charter.

The said board shall also have full power and authority to borrow money through the execution of promissory notes, mortgages and other securities, to execute mortgages and issue notes, bonds or other obligations in such a manner and on such terms as in their judgment may be advantageous, and generally to do all the things necessary for the proper carrying on of the business of the said corporation, and to execute and deliver full paid shares of stocks and bonds or other obligations of the said corporation in payment of the money borrowed or money, labor, services, property or rights actually received by the said corporation, as heretofore set forth. At any meeting of the board of directors, any director absent from the meeting may be represented by any other director, who may cast the vote of said absent director, as authorized by written instructions of the said absent director. The board

and to make and establish such by-laws, rules and regulations for the proper management and control of the corporation as may be deemed necessary and expedient.

ARTICLE II.

The domicile of this corporation shall be in the city of New Orleans, state of Louisiana, and all citations or other legal process shall be served upon the president of said corporation, or in case of his absence upon the secretary of the corporation or upon the vice-president thereof.

ARTICLE III.

The objects and purposes of this corporation, and the nature of the business to be carried on by it, are hereby declared to be the manufacture of refrigerators, show cases, fixtures, furniture and all kinds of wood work, the buying and selling of same; the acting as agent for the purchase and selling of any goods or merchandise connected or incidental with their said business.

The capital stock of this corporation is hereby fixed at six thousand dollars (\$6,000.00), divided into and represented by one hundred and twenty (120) shares of fifty dollars (\$50.00) each, and this corporation shall begin business when five thousand dollars (\$5,000.00) of the said capital stock shall have been subscribed to and paid for.

ARTICLE V.

All the corporate and control of this corporation shall be vested in and exercised by the board of directors, composed of three stockholders, a majority of whom shall constitute a quorum in the transaction of business.

ARTICLE VI.

The directors of said corporation shall be elected annually at a meeting of the stockholders to be held on the first Monday of January of each year. At a meeting of the stockholders, each stockholder shall be entitled in person or by proxy, to one vote for each share of stock owned by him. All meetings of stockholders and elections shall be held under such rules and regulations and for the election of directors and officers as shall be adopted. The board of directors thus elected shall continue in office for one year and until their successors shall have been elected and qualified, and on failure to elect directors on the date specified it shall be the duty of the stockholders to elect directors, who shall be elected by ballot.

The board of directors at its first meeting shall elect a president, vice-president and secretary-treasurer. One person may hold one or more of these offices.

The board of directors may, from time to time appoint all such officers, agents and employees, as it may deem necessary for the purpose of carrying on the business of the corporation, and to define the duty of every officer and employee, and to make and establish such rules and regulations as may be necessary and proper for the support and management of the business and affairs of said corporation.

ARTICLE VII.

Until the first meeting to be held on the first Monday of January, 1914, the following named persons shall constitute the first board of directors, viz: Henry Wendel, Sr., president; John G. Wendel, vice-president, and Louis A. Wendel, secretary-treasurer.

ARTICLE VIII.

No stockholder shall be held liable or responsible for the contracts, debts, faults and defaults of said corporation, nor shall any mere informality in its organization or in the effect of recording its charter null, or exposing the stockholders to any liability beyond the unpaid balance on the shares of stock owned by him.

ARTICLE IX.

Whenever this corporation shall be dissolved, either by limitation or otherwise, its affairs shall be liquidated by two commissioners, to be appointed by the stockholders at a general meeting held for that purpose. Said commissioners shall remain in office until the affairs of said corporation shall have been fully liquidated, and in the event of the death of one of said commissioners, the survivor shall complete the liquidation.
