**CHARTER OF THE CENTRAL GAS AND OIL COMPANY.**  
 United States of America, State of Louisiana,  
 Parish of Orleans, City of New Orleans.  
 Be it known, that on this 15th day of De-  
 cember, 1914, before me, Gustaf R. Westfeldt, Jr.,  
 a notary public, duly commissioned and qual-  
 ified, in and for the parish of Orleans,  
 Louisiana, and in the presence of the wit-  
 nesses hereinafter named and undersigned,  
 personally came and appeared, the several  
 persons whose names are hereto subscribed,  
 who severally declared:

That availing themselves of the provisions  
 of this state relative to the organiza-  
 tion of corporations, they have con-  
 tracted and agreed, and do by these presents  
 contract, agree and obligate themselves into  
 a corporation, and body politic in  
 law, for the object and purposes and un-  
 der the conditions and stipulations of the  
 articles following, to-wit:

Article I.—The name and title of the said  
 corporation shall be "The Central Gas and  
 Oil Company," and under its said corporate  
 name it shall have power and authority; and  
 shall enjoy succession for the full term and  
 period of years hereinafter expressed, and  
 after the date hereof; to contract, sue and be  
 sued; to make and use a corporate seal, and  
 the same to break and alter; at pleasure; to  
 purchase, hold, sell, lease, mortgage, hypothecate  
 and otherwise dispose of real and personal  
 property, to contract and sue, to employ man-  
 agers, directors, officers and agents as the in-  
 terest and convenience of said corporation

 gas land and oil, mineral and gas rights, and  
 any other interest in lands, both in Louisiana  
 and elsewhere, drilling outfits, machinery, ap-

 cess, handling, refining and transportation of  
 the same when so extracted, and particu-  
 larly for the uses of its own business and for
