INTERNATIONAL MILLING & RICE CORPORATION, INC. United States of America, State of Louisiana, Parish of Orleans, City of New Orleans.

Be it known, That on this 22nd day of the month of December, 1917, in the Parish of Orleans, State of Louisiana, before me, Charles Rosen, Notary Public, duly commissioned and qualified, in and to the presence of the undersigned witnesses, the following instrument was presented to me and read aloud to the witnesses and to the subscribers hereinafter named and undersigned, who are present and appeared, the several names are hereunto subscribed, who have declared that availing themselves of the provisions of the laws of Louisiana, they have agreed to incorporate themselves as a corporation under the laws of Louisiana, and to the following articles and stipulations, to-wit:

Article I.—The name of this corporation shall be International Milling & Rice Corporation, Inc. Its period of duration shall be for a term of ten years, commencing on the day of the date of the filing of this charter with the Secretary of State, and shall terminate on the day of the expiration of said term, unless the same shall be renewed by the affirmative vote of a majority of the stockholders of this corporation, as hereinafter provided.

Article II.—The objects and purposes for which this corporation is organized, shall be to acquire, own, lease, hold, operate, manage, control, and sell, in whole or in part, all kinds of real and personal property, and to do all things necessary to carry out the objects and purposes of this corporation, and to do all things necessary to carry out the objects and purposes of this corporation, and to do all things necessary to carry out the objects and purposes of this corporation.

Article III.—The amount of the capital stock of this corporation, as hereinafter provided, shall be Ten Thousand (\$10,000) Dollars, divided into One Hundred (100) Shares, of the par value of One Hundred (\$100.00) Dollars each, and shall be paid for in cash, or in kind, or in any other manner, as hereinafter provided.

Article IV.—The Board of Directors of this corporation shall be composed of five (5) members, who shall be elected by the stockholders of this corporation, at a meeting called for that purpose, and shall hold office for a term of one (1) year, and until their successors are elected.

Article V.—The Board of Directors of this corporation shall have full power and authority to fill vacancies in their number, caused by death, resignation, or otherwise, and to do all things necessary to carry out the objects and purposes of this corporation, and to do all things necessary to carry out the objects and purposes of this corporation.
