**CHARTER OF  
HARPER STAVE & LUMBER COMPANY,  
INC.**  
United States of America, State of Lou-  
isiana, Parish of Orleans, City of New  
Orleans.

Be it known, That on this twenty-third day  
of the month of March, in the year one  
thousand nine hundred and eighteen, Before  
me, Charles Rosen, a Notary Public, duly  
commissioned and qualified, in and for the  
above Parish, therein residing, and in the  
presence of the witnesses hereinafter named  
and undersigned; Personally came and ap-  
peared the several persons of the full age  
of majority, whose names are hereunto sub-  
scribed, to make and ratify, to make and  
execute the laws of this State in such  
cases made and provided, they do hereby  
furnish themselves, their associates, successors  
and assigns, into copartners in the manage-  
ment of the corporation, which they hereby adopt  
as their charter to-wit:

Article I.—The name of this corporation  
shall be Harper Stave & Lumber Co., Inc.,  
its period of duration shall be ninety-nine  
years from this date. Said corporation shall  
have, for the purpose of the business to be  
carried on by it, all the powers conferred  
by law upon corporations, and shall gener-  
ally exercise all the powers necessary to  
carry on said business. Said corporation  
shall have full power to contract, sue and  
be sued in its corporate name, to make and  
use a corporate seal, and the same to break  
and alter at pleasure; to hold, receive pur-  
chase, rent, or otherwise acquire, and to  
convey, mortgage, hypothecate, lease, sell  
pledge, or otherwise dispose of property, real  
personal and mixed; to issue bonds, notes  
or other obligations; to have and employ  
such managers, directors, officers, agents and  
other employees as the interest and con-  
venience of the corporation may require or  
demand; to make and establish such by-  
laws, rules and regulations for the manage-  
ment and control of the business and affairs  
of the corporation as may be deemed neces-  
sary or expedient.

Article II.—The domicile of the corpora-  
tion shall be in the City of New Orleans,  
State of Louisiana; and all citation and other  
legal process shall be served on the Presi-

dent, and in his absence upon the Secre-  
tary.

Article III.—The objects and purposes for  
which this corporation is organized, and the  
nature of the business to be carried on by  
it are hereby declared to be: To manu-  
facture, buy and sell staves, lumber, logs,  
and other products of every descrip-  
tion; to acquire and operate mills for the  
manufacture and production of the above  
named products; and in connection therewith  
to own and operate railways, tramways,  
barges, boats and vessels of every character  
and description, camps, commissaries and  
stores, including the purchase and sale of  
farm products and merchandise of every  
description; to acquire, sell or otherwise dis-  
pose of timber, land and timber rights, and  
real and personal property of every descrip-  
tion, and generally to do everything inci-  
dental to or connected with the above named  
purposes.

Article IV.—The amount of the capital  
stock of this corporation is hereby declared  
to be Ten Thousand (\$10,000) Dollars, con-  
sisting of one hundred shares of the par  
value of one hundred (\$100) Dollars per share.  
One half of said amount shall be subscribed  
before the filing of the articles of incorpora-  
tion, and the balance shall be paid in cash  
or property at the option of the subscribers.  
The remainder of the authorized capital  
stock, whenever subscribed and issued, shall  
be paid for in money or property actually  
received, or in property for the corporation,  
upon such terms and conditions as the Board  
of Directors shall deem proper, provided that  
the stockholders of record at the time of  
issuance shall have the right to subscribe  
thereto in proportion to their respective  
holdings.

The amount to which the capital may be  
increased is Twenty-five Thousand (\$25,000)  
Dollars. All transfers of stock shall be  
made on the books of the company on the  
presentation of the original certificate there-  
of, and in accordance with the provisions  
pursuant to such rules as the Board of Direc-  
tors may prescribe.

No stockholder shall have the right to sell  
or otherwise dispose of his stock without  
first offering it to the other stockholders  
through the Board of Directors for thirty  
days at its book value for cash; and all  
stock shall be sold to the other stockholders  
and every sale, pledge, encumbrance or other  
disposition of said stock shall be made sub-  
ject to this provision of the charter.

Article V.—All the powers of this corpora-  
tion shall be vested in and the business and  
affairs of the corporation managed by a  
Board of Directors, who shall consist of not  
more than three nor less than five mem-  
bers, who shall be elected annually at a meet-  
ing of the stockholders on the first Monday of  
April of each year, and the election shall be  
held on the first Monday of April, 1919, until  
which time the officers and directors named in  
this charter shall act, or until their successors  
are elected and qualified.

The first Board of Directors to serve for  
the first year shall consist of: Max Lowy, 804  
Whitney Central Bldg., New Orleans, La.;  
Edward L. Ferriday, Concordia Parish  
Louisiana; Edward Duplantier, 804  
Whitney Central Bldg., New Orleans, La.;  
and Adolph A. Leuchman, 804 Whitney Cen-  
tral Bldg., New Orleans, La.; with Max Lowy,  
President; Edward L. Harper, Jr., Vice-  
President; Edward Duplantier, Secretary,  
and Adolph A. Leuchman, Treasurer.

The officers of this corporation shall be  
President, Vice-President, Secretary and  
Treasurer; but the Board of Directors may  
at any time elect or appoint such other  
officers, agents or employees as they desire,  
and determine their duties; and may at any  
time combine the office of Secretary with  
that of Treasurer, under title of Secretary-  
Treasurer.

All elections shall be by ballot at the office  
of the Company, under the supervision of  
two commissioners to be appointed by the  
Board of Directors. Notice of such meet-  
ings shall be given by the Secretary in writing,  
and delivered to each stockholder in person,  
or mailed to his last known address at least  
ten days prior to said election; but this  
notice may be waived by all the stockholders.  
At all such meetings, and at all meetings  
of the stockholders, each stockholder shall  
be entitled to vote in person, or by proxy,  
stock standing in his name on the books of  
the Company at the date of such election or  
meeting; said votes to be cast in person  
or by proxy, and a majority of the valid  
votes cast shall elect. In the event of the  
failure to hold the annual meeting, any stock-  
holder may have the right to require the  
calling of such meeting at any time there-  
after.
