

NIGHT TO KEEP CANAL STREET OPEN

ALGIERS DELEGATION AGAIN TAKE UP MATTER.

Several articles appearing in the daily papers in which were stated that the Dock Board had made the concessions demanded by the public, to leave a large open space at the head of Canal St. are misleading for the fact that the Dock Board agreed to cut off sixty feet of the present warehouse which they are now erecting across Canal St. The sixty foot concession made by the Dock Board is insignificant and does not relieve the condition one iota. Mr. Peter S. Lawton, Charles Donner and C. V. Kraft held several conferences Monday with the city officials and took up the matter with some members of the Constitutional Convention. Charles Donner left Monday night for Baton Rouge to confer with Governor Parker in our effort to incorporate into the constitution a clause in the present Dock Board ordinance that will forever keep open the large neutral grounds at the head of Canal St. Mr. Peter S. Lawton also spoke before the Federation of Women's Clubs on the matter and the club as a body will give their assistance to prevent the Dock Board from closing up this large river entrance to New Orleans.

The amendment proposed by the Algiers delegation to the Dock Board ordinance in the new constitution is as follows:

"Provided, That the City of New Orleans shall have exclusive control of the 486 lineal feet of water front between the present Poydras and Bienville street sheds at the foot of Canal street, for ferry purposes forever; and,

"Provided, further, That said City of New Orleans shall have exclusive control forever of all that portion of the land area between said sheds, not necessary for ample approaches to said structure, said land to be devoted exclusively to ferry purposes and such civic embellishments as said city may decide upon, all as per attached sketch made part of this act."


MISS SWEENEY ENTERTAINS.



The big ice plant of Sid. M. Cafiero which was sold some fifteen days ago to Mr. Wallace Trowbridge was again resold to Mr. Cafiero a few days ago.

The corporation has been formed with the capital stock of \$49,500, which takes over machinery, plant, real estate, fixtures, furniture, and all other portions connected with the former ice plant. The new corporation is to be known as the Cafiero Ice Works, Inc., of which Mr. Sidney M. Cafiero, former owner of the business, is president, Ed. M. Cafiero vice-president, and George J. Smith secretary-treasurer. Mr. Sidney Cafiero is well known in Algiers, having been the former owner of the ice plant. His brother, Ed. M. Cafiero, who for several years has been analytical chemist in the city, leaves that profession to become vice-president. George J. Smith, who is presently connected with the Grand Isle Railroad, and who has been with that company a good many years, becomes the secretary-treasurer of the ice works.

The new company is already working under its new organization, and the shares in the corporation are equally divided among the three men above mentioned.

ALGIERS BANK GOES OVER THE TOP

CAPITAL STOCK SUBSCRIBED; WILL OPEN ABOUT JULY 11TH.

Mr. Adolph Spitzfaden, the cashier and manager of the new Algiers Trust and Savings Bank, made a statement yesterday that more than \$250,000 has been subscribed for the new bank, and that the over-subscription would be prorated with the large subscribers according to the amount of the subscription. Mr. Spitzfaden stated that the new bank will not stop taking subscriptions for stock on account of the over-subscription as all those who desire to take stock in the bank may do so up to July 11. As additional stock is subscribed this amount will be deducted from the large stock holders. It is the object of the bank to have as many stockholders as possible. The banking house which will be located at the intersection of Verret, Eliza and Bermuda Sts., the McGivney property, is now undergoing alterations, and will be ready for occupancy about the first of July.
