### A Disreputable Den.

Complaint has been entered at this office in regard to the outrageous and scandalous conduct of the negroes that assemble nightly at Leonard Manso's "restaurant" on Landry street, near the bridge. Our informant says that the language used by the inmates of this den is enough to make a hardened criminal blush, and that ladies living near by are often worried by it. This rowdism is kept up to a late hour, and on Saturday night even later. We are also told that complaint has several times been made to the town authorities, but nothing has been done in the premises. It is bad enough that such dens should exist, but it is still worse when they become a public nuisance. Can't the town authorities look into the matter and put a quietus on Manso's den?

### Killing At Whiteville.

An unfortunate, and fatal difficulty happened in Whiteville, this parish, last Saturday evening, the consequence of which is that one man is dead and another is charged with the deed. John Foret is the dead man, and his slayer is John H. Sandifer, and the difficulty between them, which terminated so sadly, was the direct result of liquor.

Sandifer claims self-defense. He says, and several witnesses corroborate it, that Foret was advancing on him with a knife when he shot him.

Sandifer has surrendered to the sheriff.

### Mr. Joe Chachere Dead.

The community was greatly shocked on Tuesday last to hear that Mr. Joseph Chachere, a highly-respected and well-known farmer of West Bellevue, was dead. His death was brought about by a severe attack of pneumonia, and not old age, as some might suppose. He was the son of Veillon Chachere, who only died a couple of years ago. Mr. Chachere was interred in the Catholic cemetery Wednesday forenoon, and his remains were followed to their last resting place by a large concourse of relatives and friends.

### Needs Repairing.

We would call the attention of the road overseer to the dangerous condition of the ground bridge across the mud hole just west of town, near Louis Christ's store. The bridge in question is quite a poor affair, the planks not being nailed to the sleepers. Every time a heavy rain falls—like the one last Monday night—many of the planks float away, and the ones that remain are loose. This condition makes it dangerous for travel, and the overseer should have it repaired at once.

### Public Schools Open.

All the public schools of the parish opened last Monday, after having been closed for two weeks on account of the Christmas holidays. There will be no more holidays of any consequence before the summer vacation, and it behooves the pupils to put their time to the best use and acquire as much knowledge as is possible between now and the close of the session.

### A Big Crop.

Mr. J. Richard Cottingham, the manager of the Holland plantation in Bellevue, will plant thirty-five acres of sweet potatoes this year. In an ordinary season that much land will raise 3500 barrels or more. Mr. C. will water his potatoes. We will wager that this section can raise more potatoes per acre than any other place this side of "kingdom come."

### An Epworth League.

We are informed that Rev. J. A. Parker, of the M. E. Church, will form an Epworth League at an early date. The League will be composed of members of the different churches, and will labor for the christian cause. The Clarion wishes the League much success in its field of labor.

### Electric Lights Again.

Mr. Bell, who is trying to get the contract to put in a system of waterworks and electric lights in our neighboring town of Lafayette, was here this week to see what prospects there were of putting in a system here. He left Wednesday, and we were unable to hear if he had accomplished anything. We hope either he or someone else will get the contract, for it is about time for Opelousas to get out of the old rut.

### School Board Meets.

In another column we publish the proceedings of the School Board, which met in regular session this week. The Board appointed Mr. W. Boudreau, of Grand Coteau, as assistant principal of the High School, at a salary of \$60 per month. The Board also increased the salary of Prof. E. E. Ortega, of the Ville Platte School, from \$60 to \$75 per month; also an increase of \$15 per month at Washington.

### Crop Season Near at Hand.

Some of the "early-bird" farmers have already begun work for this year's crop. We note that several have cut stalks on their land and one or two have begun breaking land. This is a pretty fair indication that the farmers are going to try and get in their crops as early as possible. It is generally the rule that early-planted corn, cotton, etc., always do the best—only in off years that late-planted crops do well.

### Storeroom Burned.

On Thursday at 4 a. m., January 2, the store room of Mr. Francois Dossmann, near Ville Platte, was destroyed by fire, together with its contents, consisting of about 100 sacks of rice, 4500 pounds of cotton, a lot of provisions, carpenter's tools, etc. The amount of the loss is about \$500, with no insurance.

Mr. Larcade moved that the mayor appoint a committee of two to advertise for bids to lay a plank walk from the depot on the North side of Bellevue street to the public cemetery. Mr. Roos seconded the motion. An amendment accepted by original mover, and as amended, the motion passed. Larcade and Hebrard were appointed on committee.

On motion of Hebrard, W. R. Cochran was awarded the contract to make the roll at the usual price—twenty-five dollars.

Delegations from different parts of the parish appeared before the Board requesting the appointment of teachers and assistants.

On motion of Dr. Irion, Miss Anita is appointed assistant of the Chatagnier school at \$15.00 per month.

On motion of T. R. Carroll, Miss Minty Morris is appointed assistant of Bevier school at \$15.00 per month, and Miss Evie Brewer assistant of Stewart school at a salary of \$25.00 per month.

On motion of W. S. Frazer, \$25.00 per month is approved for the assistant at Eunice to be appointed by supervisor of 8th district.

On motion of J. L. Guillbeau, Wilfred Boudreau, south of Eunice, and High School at a salary of \$90.00 per month.

On motion of Dr. Cook, \$15.00 per month is added to the salary of A. V. Bie and one of High School, whose amount is added to salary of B. E. Ortega.

On motion of Dr. Irion, \$75.00 is appropriated out of district funds for furnishing 5 stoves for High School building.

On motion of A. L. Fontenot, resolved, that whereas it is important to the perpetuity of the public school system of this State that the High Schools should keep in close touch with each other, and pursue a uniform line of work with a view of articulating said High Schools, our best Talented youth should be placed in a uniformity of action has heretofore existed among said High Schools, each pursuing independent and in many cases widely different courses.

Therefore, be it resolved, that the Board favors a conference of all High School Principals throughout the State to be held at an early date, and at some central point, with a view of bringing about this desired co-operation, and the Principal of the St. Landry High School hereby requests to communicate with other High Schools and agree upon a time and place of meeting.

Resolved further, that in this movement we respectfully invite the cooperation of the School Boards of all parishes wherein High Schools exist, and suggest that each of said Boards send a representative of the said conferences in addition to Principal of High Schools.
