

PROBABLY RE-WRITE STATE CONSTITUTION AND IS GREATLY NEEDED

Present Constitution is in Reality the Constitution of 1879, as Convention of 1898 Devoted Time to Negro.

The Baton Rouge State says that the subject of holding a constitutional convention for the purpose of rewriting the Constitution of Louisiana is being extensively discussed in high official circles.

"The need for a convention is going to be more evident when the Legislature tries to pass some advanced and progressive laws on the subject of taxation," said one official in discussing this subject.

"The subject will be one for consideration when the legislature is convened. There are important measures in regard to taxation that are to be taken up, and among them is the adoption of some provision removing the tax from mortgages in Louisiana.

Not a session of the General Assembly is held but that a number of amendments to the Constitution are offered and usually four or five are voted upon at every general election.

PASSOVER OF ORTHODOXS. Peculiar Custom Followed by the Orthodox Jews in the Observance of Passover.

The New Orleans Picayune of last week contained an exceptionally interesting article on the observance of the passover by the orthodox Jews of New Orleans.

While Israelites are observing more or less strictly the week of the Passover, to the poorer classes of Jewish immigrants residing in the neighborhood of Poydras Market the occasion is one for the complete following of the dictates of the Orthodox ritual.

Perhaps the most imposing of these places is that conducted by H. Sokol, and located at 629 Dryades. It is more of a boarding house for Jews who come to New Orleans from foreign countries than anything else.

A unique gathering took place Wednesday and Thursday nights in the dining-room of this little house. Although only a very small place, the tables were spread out lengthwise, so that it was possible to accommodate about thirty people.

Here to the menu that was served: Hard boiled eggs, dressed fish with horseradish, chicken soup, matzo cakes, with chicken and potatoes, kosher wine and brandy, and plums.

kosher wine and liquors made through a special process is allowed. The plates, knives, forks, napkins, spoons, tablecloths etc., are kept separate for Passover. Mr. Sokol, immediately after the work, will remove the tableware and store it away until next year at the same time, when it will be taken out again.
