Proceedings Police Jury.

By Mr. Pierson, seconded by Mr. Knott:

Be it ordained by the Police Jury of the parish of Natchitoches, Louisiana, that in accordance with the petition of citizens hereto attached and made part hereof and the ordinance of this body this day passed creating Road District No. 14 of the parish of Natchitoches a special election is hereby ordered to be held in Road District No. 14 in the parish of Natchitoches on May 10th at Cragle School House which shall be submitted to the property taxpayers of said District 14 eligible and qualified to vote at such election the following proposition:

To levy a special tax of five mills on the dollar on all assessable property in Road District No. 14 of the parish of Natchitoches embracing and including the following territory:

All that portion of ward ten bounded on west by range line between range five and four, embracing all that territory north of the Texas & Pacific Ry., and between Cane River and boundary line of Rapides parish, running to Red River. Said tax to exist for a period of ten years beginning with and including the year 1915, ending with and including the year 1924. Said tax to be devoted to the construction and maintaining of public roads in said district No. 14.

Section 2. That the Secretary of the Police Jury is hereby instructed to have prepared for use at the said election a sufficient number of ballots on each of which shall be printed the proposition mentioned and set forth in section 1 of this ordinance in the following form to-wit:

BALLOT.

Proposition to levy a Five Mill Special Tax on the Dollar on all assessable property in that portion of Ward Ten of the Parish of Natchitoches known as Road District No. 14 for a period of Ten years from and including the year 1915, to and including the year 1924, for the purpose of constructing and maintaining public roads in said District No. 14 of the Parish of Natchitoches, La.

Notice to Voters: To vote in favor of said proposition place a cross (X) mark in the square under the word YES, to vote against said proposition place a similar mark under the word NO.

Section 3. That the Secretary is hereby instructed to have prepared for use at said election all necessary ballot boxes, tally sheets, list of voters, assessed valuation of property and compiled statement of voters in number and assessment.

Section 4. That said special election be held in accordance with the laws of the State and at Cragle School House of Ward 10, Parish of Natchitoches, the following are hereby appointed Commissioners to serve at said election, viz:

R. J. Merrell, H. E. Anderson, and J. M. Cotton, Commissioners, and Houston Wise, Clerk of said election.

Section 5. That the President of the Police Jury is hereby instructed to issue his proclamation giving notice of this special election herein ordained and to announce that at 10 o'clock a. m., Monday the 20th, day of May 1915, this Police Jury will meet at the Court House in the City of Natchitoches, La. and open the ballot boxes and count the ballots in number and amount and declare the result thereof.

By Mr. Pierson: That the following petition of citizens of Ward 9, be accepted. To the Honorable Police Jury of the Parish of Natchitoches:

We the undersigned tax payers of ward 9 of the parish of Natchitoches, Louisiana, in order to construct, maintain, gravel or dirt public roads within the limits of the territory hereafter set forth, respectfully petition your Honorable body to create a road district embracing the following territory and portion of ward 9 of the Parish of Natchitoches, viz:

Commencing at the corner of Section 57 and 58, township 10, range 7, on the ward line between wards 1 and 9, and running thence west along the north line of ward 9 to its intersection with the East line of ward 6; thence running north along the ward line between wards 7 and 9 to the South west corner of section 7, township 7, range 7; thence east along the ward line between wards 7 and 9 to the south east corner of section 12, township 7, range 7; thence south on the ward line between wards 7 and 9 to the middle of section 56, township 7, range 6; thence east along the center of section 56 across Old River to the dividing line between section 72 and 73; thence in a northeasterly direction along the line between section 72 and 73 to the south line of section 9, township 9, range 6; thence along the south line of said section 9 to Cane River; thence in a northerly direction along the west bank of Cane River to the point between the property of J. Alphonse Prudhomme and Carrol Jones on the Bank of Cane River where the south line of Road District No. 13, commences; thence along the south and west line of said Road District No. 13, to the point of beginning.

And that the same be designated as Road District No. 13, of the Parish of Natchitoches, Louisiana.

We agree to vote a special tax when submitted to a vote to incur an indebtedness of (\$50,000.00) Fifty Thousand Dollars, the same to bear interest at the rate of 5 per cent per annum, principal and interest to be paid by special tax on all assessable property in said road district No. 13, the amount of the said tax to be levied annually by the Police Jury not to exceed 10 mills in any one year, to run for 20 years the said tax to be devoted to the construction and maintenance of a gravel road running from a point on the bank of Cane River through or near the planta-

tion of Matthew Jones, thence to Cypress on the T. & P. Railroad, and thence west along the right of way of the T. & P. Railroad, to the Bayou crossing said Railroad, which is called Bayou Sac de tabac, and the improvement by graveling or otherwise, and maintenance of such other public roads now existing and which may hereafter be created in said territory and running through said road district No. 13, as above designated and described.

It being understood that when a sum sufficient to pay said principal and interest shall be collected, there shall be no further assessment and levy of said tax, and that the tax so voted shall be funded into bonds to run for 20 years, the amount of said bonds to be fixed by the Police Jury, the same to bear 5 per cent interest per annum.

And we further pray that your Honorable body submit said matter to the qualified voters of said road district No. 13, at a special election to be called as soon as possible.

AN ORDINANCE

By Mr. Pierson, Seconded by Mr. Page:

Be it ordained by the Police Jury of the Parish of Natchitoches:

Sec. 1. That a special election be and the same is hereby ordered to be held in Road District No. 13 at Cypress in the Parish of Natchitoches, being polling place No. 2 of ward 9, on Tuesday, May 18th, 1915 at which shall be submitted the proposition to-wit:

To incur debt and issue bonds to the amount of Fifty Thousand Dollars to run for Twenty (20) years to-wit: 1915, 1916, 1917, 1918, 1919, 1920, 1921, 1922, 1923, 1924, 1925, 1926, 1927, 1928, 1929, 1930, 1931, 1932, 1933, 1934, to bear interest at the rate of Five per cent per annum, said interest payable annually for the purpose of constructing and maintaining a gravel road from a point on Cane River through or near the plantation of Matthew Jones; thence to Cypress on the T. & P. Ry. thence west along the right of way of the T. & P. Ry. to Bayou Sac De Tobac, which crosses said Railroad, and the improvement by graveling or otherwise and maintaining of such other Public Roads in said Road District.

Sec. 2. That the Secretary of the Police Jury be and she is hereby instructed to have prepared for use at said special election a sufficient number of ballots, on each of which shall be printed the proposition embraced in Section One of this ordinance in the following form:

BALLOT.

Special election in Road District No. 13 of the Parish of Natchitoches, La. held in accordance with the laws of the State and the Police Jury of the Parish of Natchitoches adopted on the 6th, day of April 1915, Proposition to incur debt and issue bonds to the amount of Fifty Thousand Dollars to run for Twenty (20) years from date and to bear interest at Five (5) per cent per annum, payable annually for the purpose of constructing and maintaining a gravel road from a point on Cane River through or near the plantation of Matthew Jones; thence to Cypress on the T. & P. Ry. and thence west along the right of way of the T. & P. Ry. to Bayou Sac De Tobac, which crosses said Railroad, and the improvement by graveling or otherwise and maintaining of such other public roads in said Road District all in conformity to an ordinance in reference thereto adopted by the Police Jury of the Parish of Natchitoches on April 6th, 1915.

M. L. Payne is appointed Clerk of said election, and said election, shall be conducted under the laws of the State of Louisiana applicable thereto.

Sec. 4. That the President of the Police Jury is hereby instructed to give notice of the special election ordered by his proclamation publishing according to law, and in said proclamation he shall announce that at 10 o'clock a. m. the 20th, day of May 1915, the Police Jury will meet at its regular meeting place in the City of Natchitoches, La. in open public session, proceed to open the ballot boxes, examine and canvass the returns of said special election.
