## STATE TAX SALES

### Of Immovable Property of the State of Louisiana vs Delinquent Tax Debtors for the Year 1914.

By authority vested in me by the Constitution and Laws of the State of Louisiana, I will sell at the principal front door of the Court House in which the Civil District Court of said Parish is held within the legal hours of sale, beginning at 11 a. m. on
