Police Jury Proceedings.
By Mr. Pierson:
That the following petition of Citizens of Ward Four be accepted.
We the undersigned Citizens of Ward Four do hereby pledge ourselves to vote a Special Tax when submitted to vote at a Special election to be ordered by your Hon. Body to incur an indebtedness of Twenty Thousand, principal and interest to be paid by a Special Tax on all assessable property in said Road District, known as No. 18. The amount of said taxes to exceed Ten Mills in any one year for twenty years.
The said tax to be devoted to the construction and maintenance of a Gravel Road from the Maricelli School House on Bayou Bourbeaux to the Village of Campiti, for the construction and maintenance of other roads in said District. It being understood that when a certain sum sufficient to pay said principal and interest shall be collected there shall be no more further assessments and levy the said tax and that the tax so voted shall run for Twenty years. The amount of said bonds to be in even numbers to be fixed by the Police Jury. The same to bear 5 per cent per annum interest payable annually.

Road District No. 18, commencing at a point on the west side of right away of the L. R. & N. Co. at the North East corner of Section 49, T. 10 North range Seven West, where the South line of road District No. 15, end on said right away, thence running South along the Western side of the right away of the L. R. & N. Co. to the West line of section 30 where said Railway crosses the west line of the section 3, thence north range six west, thence north along the western line of section 30, north range six west, thence north along the western line of section 30, to the south line of section 19, thence east along the section line between sections 19 and 30 to the southern east section line, to the south east corner of section 19, thence south along the section lines between section 30 and 29 thence east to the center of the south line of section 28, thence north to the center of section 27, thence east to the line of section 27, thence north between section 27 and 28, and between 21 and 22 to center of 15 and 16, T. 10 north range 5 west, thence east to section 14, thence north to the south west corner of section 11, thence east to Black Bayou thence north in a north-westerly direction along the ward lines between 2 and 4 the middle of the north section line of section 5 T. 11, north range 7 west thence west to the range line of range 8, west which is the boundary line of ward 3 and 4, thence south along said range line to the south west corner of section 18, T. 11, north range 7 west, which point is the line of the road district No. 15, thence southerly along the eastern line of Road District 15 to the point of beginning of same, to be designated as Road District No. 18.

Now we pray that your Honorable Body do call a special election and submit said matter to the qualified voters of said Road District No. 18 as soon as possible.
