#### Habits of English Orators.

The accident which befell Lord Rosebery's notes at Plymouth has set people discussing the practice of various speakers in regard to the preparation of their speeches. The most inveterate writer-out of his speeches was the late Lord Derby; the manuscript of one of his most statesman-like discourses being picked up from the floor, where it had fallen, was found not only to be freely sprinkled with "Dear, hear," "Laughter," and "Applause," but also to contain a passage beginning "But I am detaining you too long (cries of 'No, no,' and 'Go on')." Sir William Harcourt used to declaim his great orations in the country from sheets of manuscript written within and without. Mr. Gladstone used to make fiery full and extremely distinct notes. His splendid dexterity in the use of them made his hearers forget their existence. Mr. Bright used to say that the right way was to prepare a certain number of "islands"—meaning neat and pointed sentences—and that one should then trust one-self to swim out by extempore effort from island to island, reserving always the best island for the peroration. Mr. Asquith's speeches, "faultily faultless, icily regular," always strike one as being, like Macaulay's and the late Lord Sherbrooke's learnt by heart and delivered from memory.
