Dear Sir—Your attention is respectfully called to the following extract from the plan of work adopted by the Board of Managers of the World's Industrial and Cotton Centennial Exposition, June 12, 1883:

There shall be a special exhibit for the State of Louisiana, under the same general rules and regulations that apply to other exhibitors, and for the purpose of securing the utmost possible representation from the State the Governor shall be requested to constitute a Louisiana State Commission, of which he shall be ex-officio chairman, the commission to include the Governor, Secretary of State, Commissioner of Agriculture and a Commissioner from each parish in the State, in addition to the Commissioner and alternate Commissioner appointed by the Governor and commissioned by the President of the United States.

In accordance with the foregoing plan I have the honor to request that the Police Jury of your parish select a capable and energetic citizen to be appointed and commissioned by me as member of the said Louisiana State Commission. If the regular meeting of your Police Jury is not near at hand you are requested, as President thereof, to select a Commissioner, and to forward his name to this department.
