The Improvement of the Teche.

Representatives Broussard and others from Louisiana are making every effort to secure large appropriations for the improvement of the water ways of Louisiana, and the following bit of news concerning this section, which we took from the news sent out from Washington last Saturday, will be of some interest to our people, it follows:"

"Improving Bayou Teche, La., with a view of obtaining a six-foot navigation to Arnaudville, in accordance with the report submitted in House document 527, first session. Fifty-ninth Congress, and for maintenance, \$118,500; provided that this expenditure for sixfoot navigation to Arnaudville shall be contingent upon all lands necessary for lock and dam purposes and canal feeders being ceded to the United States free of cost, and Thousands of persons are healed gal sale hours, on upon the United States being secured against possible claims for damages resulting from overflow Trial bottle free. of lands by reason of lock and dam improvement, or from draining of Spanish Lake."

The opening for navigation of the Teche to Arnaudville by dredging a six foot channel all the way through, would make the Teche one of the most important streams in the state.

Now if Coulee Pointe Clair could be dredged and made to connect with the Teche and also Bayon Portage just above Breaux Bridge, this would throw the whole of the swamp trade and the vast lumber industries of the Cypress swamps in easy reach of the Teche country, and this alone would be worth pretty cool and Monday was millions of dollars, as the facilities would such be that saw mills and many other wood industries could be located on the Teche or even in the swamps and their product brought to market without long and dangerous routes through the

Such improvements would be of such great benefit to the Teche country, that our people can hardly realized of what magnitude it would be

Let us hope that all these projects will soon be realized.

Murder Case,

A Morgan City special to The Times - Democrat dated January 18th says:

"As the result of a family quarrel a sad tragedy was enacted at Cypress Island yesterday. The coroner's inquest held by Dr. Tarleton here to-day brought out the following evidence:

Mrs. Spangler lives at Chicot Pass, in St. Martin Parish, with one of her sons, who keeps the goverment light at the pass, and yesterday came down Grand Lake about ten miles to Cypress Island, where her son and a daughter, Mrs. Puckett, live, to collect \$10 which she said was due ber from Mrs. Packett.

The two women became involved in a quarrel and Mrs. Puckett struck ber mother over the head with an iron poker, inflicting a severe wound. She then secured a hatchet and drove her mother out ot the house. The old woman went to the dwelling of her son, a short distance away, and told ber nephew about her treatment. Securing his gun, Fred Spangler, accompanied by his younger brother, Eddie, went to the Puckett house. The Pucketts, husband and wife, met them at the door and a general shooting took place, Fred Spangler being shot in the breast and back of the head by Puckett and Eddie Spangler in both feet by Mrs. Puckett.

The two Spaugler boys were brought to Morgan City at once burt. It is said that Puckett has gone to St. Martinville to surren-

On hearing of the murder Deputhe scene of the shooting, but learned the Pucketts, man and wife were at Franklin on their way here to surrender and returned with the prisoners Saturday afternoon and placed them in the parish jail to await the action of the Grand Jury which will probably meet next March at the next criminal term of the District Court.

This case, like all the others that came from the distant swamps, will prove a very expensive one for the parish as all the witnesses will have to travel many miles to attend court.
