

The Way they Do It.

The federals having failed in nearly every attempt to raise recruits since the Manassas and other engagements, have been sorely perplexed, and the absurd falsities that are connived by the scheming "skunks," and published in the different abolition sheets, are really amusing to the observer. If one thing won't do, another will, and basing their actions on this saying, they go ahead after the manner of a blind man; they feel about them with troubling nerves, and when an object is encountered, they know not what it is, and fear it may prove unsurmountable.

The following specimen is one of the last efforts, and we have many doubts as to the success of the ruse, on the contrary, we think it will have a tendency of hurting instead of doing good. Truth will out, as they will find to their sorrow, and so soon as the truth becomes known, instead of getting recruits, they will find their loyal subjects deserting at every opportunity which presents itself.

The following appeared in the Louisville Bulletin of the 9th inst.:

The Occupation of New Orleans.—We have heard vague rumors for several days, that New Orleans had been occupied by the federal troops. Intelligence was received in this city last evening, by way of Nashville, which leads to believe that the rumor has its foundation in fact. One report, in which we place confidence, says that the federal forces took possession of the city on the 5th instant without firing a gun. It is said that the fleet, after the desertion of Ship Island by the rebels, passed Mississippi city, Biloxi, and Pass Christian, which were evacuated, and made an easy conquest of the city. It was found that the incomplete fortifications at Bay St. Louis had been abandoned by the rebels, and that the city surrendered on the 5th inst., in compliance with the formal demand of the commander of the federal forces.

The above statement is the substance of a dispatch said to have been published in the Nashville papers of the 6th inst.

Extracts from a Private Letter.

Through the politeness of our friend, H. P. Hyams, Esq., we make the following extracts from a letter received from a member of the Shreveport Rebels:

COLUMBUS, Ky., Oct. 12, 1861.

I will give you some news, a part of which I witnessed. Quite a spirited engagement took place here on the 8th inst., between our batteries and some more of the enemy's waterhounds. The A No. 1 fast packet Graupus (Confederate) came down the river in double quick, giving information that they (the waterhounds) were approaching the fortifications. Everything was gotten ready and in trim, in order to give them a warm reception, which, when they made their appearance, was executed in the most elegant style possible. Two of the enemy's shells were thrown immediately into our camp, but neither did the work they were intended for, one did not even burst, it was a sixty-four pounder. After fighting hard for one hour, we forced the enemy to

"bout face." We intend to return the shell at the first opportunity.

We expect to have a little charge of musketry soon, as information has just been received that five barges are around the point, on the Missouri side, landing troops. If such is the case let them look out, for A. S. Johnson is not far behind, and when he gives the command "charge," but few will be left to tell the bloody tale.

A base creature in the shape of a woman was arrested yesterday while driving through the streets at 2:40 speed, she was steering for Cairo, and nothing more or less was found upon her, than a very poor plan of the fortifications which have been erected here.

A Lieutenant of one of our cavalry companies was killed yesterday whilst on a scouting expedition.

We publish elsewhere an article from an extra of the Southwest News published in Carthage, Mo., to-morrow we will publish other interesting particulars from the same source.—Our friend Capt. J. B. Gilmore, of the Shreveport Rangers, at Camp Jackson, forwarded us the Extra, he reports considerable sickness in the Regiment to which he is attached (3d Louisiana, McCulloch's Division) some cases of Typhoid fever. We are sorry to hear that the Captain, himself, is also unwell.

Davis and Stephens.—One paper has objected to the election of Stephens to the Vice-Presidency. But we are glad to see that the objection is universally reprobated by the press. We do not wish to meddle in politics, but we cannot refrain just now from saying that it is no time to change good officers in the teeth of battle.—We have full confidence in Davis for President, and Stephens for Vice-President; they have both acted nobly so far; let them be elected by a unanimous vote. We are in the very beginning of a great struggle and it is no time to squabble over civil offices now so worthily filled.—*Nashville Banner of Peace.*

Those are our sentiments.

The following is an extract we are permitted to make from a letter received from the Camp near Columbus, written by a Shreveport Rebel:

We have had three engagements with the Yankee gun boats within the past month. Yesterday (13th) we disabled one so badly that she retreated, up the river a distance of 10 miles and sunk, the Lincolnites are trying to raise her, and have a guard of two gun boats and 1000 men, infantry on the shore. The health of our Company is better than any of the others. If our parish forgets us we will suffer very much from the effects of the cold. Our officers now are:
