After having all the unfailing signs of rain, the clouds have passed and the dry weather continues. Some of the crops on pine land are suffering but those on hammock land have not suffered so much. The crop of beans will be short, especially on the pine lands, and the crown bloom of tomatoes is not producing any fruit. But perhaps in the long run, owing to a short crop vegetable men may receive so much better prices for what they are able to ship that they may be better off than if everyone made a heavy crop.

Mr. L. S. Light made several good shipments last week and is shipping more this week.

Mr. J. B. Devore showed us one of the finest lots of wax beans last week that we ever saw grown anywhere. They were grown on his hammock farm west of Reddick. He is shipping them this week.

The Reddick Junior High School closes on Thursday, April 23, one of the most successful terms in its history, followed by a picnic for the patrons and pupils at Orange Lake on Friday. Our people perhaps will never realize how much they are indebted to Miss Rubie Hawkins and Miss Alice Himes for their faithful, patient and untiring efforts to give their pupils every advantage possible for their advancement. Perhaps there may have been some dissatisfaction, but if so we are not aware of it. However, who ever heard of anyone teaching a school where everyone was satisfied?

A CONFEDERATE VETERAN PASSES OVER THE RIVER

After an illness of several weeks at his home in this city, Mr. Henry Clay Gates died at 2:30 o'clock Wednesday afternoon.

The deceased had been a citizen of our city for the past eighteen years and of Florida for thirty years. He was a native of Houston county, Ga., and was about sixty-five years of age. He was a member of the Marion Camp Confederate Veterans of this city, and took an active interest in the organization, and on several occasions went as a delegate to the annual reunions in different parts of the south, having attended the meetings at Birmingham, at New Orleans and at Richmond.

Mr. Gates enlisted in the 11th Georgia regiment and was in the civil war from the first battle of Manassas until the surrender at Appomattox, and at the cessation of hostilities held the rank of lieutenant, and was always a faithful and efficient soldier.

His death is very much lamented and leaves one less in the rapidly thinning ranks of those who served in that memorable struggle.

Mr. Gates leaves a widow and six children, viz: Mrs. Eula Smith of Powersville, Ga.; Mrs. Emma Smith of Perry, Ga.; Mr. Claude Gates of Washington, D. C., and Ida, Dovie and Paul Gates of this city.

The funeral services were held yesterday afternoon at 2:30 o'clock from the residence, and the body was taken to his old home at Anthony for interment. Rev. C. C. Carroll of the Baptist church conducted the ceremonies.

The pall bearers were Messrs. J. W. Lyles, J. H. Livingston, Sr., E. T. Williams, R. A. Carlton, J. A. Pittman and A. L. Eichelberger.
