OHIO.

The splendid Republican victory in Ohio on Tuesday makes the election of Blaine and Logan about as near an absolute certainty as such a thing is possible. The Buckeye state always does its duty when the maintenance of Republican principles enters into the question. The most sanguine Republicans did not figure on a majority greater than 10,000, and the party would have been satisfied with less; for it is well known that the Republicans had to contend not only with the simon-pure Democracy, but with half a dozen isms and factions, and it was the Republican party against the field, or the field against the Republican party.

The Democracy concentrated its entire strength and about all the finances at its command to make the Republican majority as small as possible, but the Blaine ticket was successful even in the Democratic strongholds, notably Cincinnati, where the Cleveland cohorts looked for decided gains and consequent encouragement.

A majority of 20,000 to 40,000 for Blaine in November may be safely relied upon, and New York will fall into line for the "Plumed Knight" with a majority that will leave no doubt in the popular mind as to the fitness of James G. Blaine to be the president of the United States.

The spinal column of the Democracy was sadly fractured in Ohio on Tuesday.

COUNTY COMMISSIONERS.

The contests in the late nominating conventions of this county centered about the offices of treasurer and sheriff, and the equally important positions of county commissioners seemed to follow as a matter of course. Less attention was paid to the three men of the county who are to have the first and last say in all things pertaining to the economic welfare of Ramsey county than to those individuals who are to fill the positions that come within the guardianship of these three men. In other words, it is the duty of the county commissioners to supervise the work of all other county officers. They are the men who are to judge of the responsibility of the bondsmen offered by the treasurer, sheriff, etc.; they are the men who pass upon all bills presented against the county; upon their order the county clerk makes all warrants against the county and the treasurer pays them.

Now (supposing the case), if the board of county commissioners should instruct the county clerk to draw a warrant as payment for a "job" that was performed for the personal benefit of one of the county commissioners, the clerk would be compelled to do so and the treasurer must pay it. On the other hand, if the commissioners should accept irresponsible men as sureties upon the bond of the county treasurer, sheriff or other officer, and it should transpire that that officer had made way with funds or had been grossly derelict in duty, the sureties being worthless, the county would be the loser to the extent of the malfeasance, and the next succeeding tax roll would perhaps be enhanced to cover the loss, to say nothing of the disgrace thus brought upon the county.

The INTER-OCEAN does not cite these suspicious cases for the purpose of reflecting upon the integrity of any man chosen by either of the conventions to fill the important financial or fiduciary offices in the county, but in our journalistic experience we have frequently been called upon to record just such transactions as are here outlined, and the regular readers of newspapers can easily recall instances of this nature which have come to their notice.

Therefore, it is highly important that men should be chosen to compose the board of county commissioners who have no personal "jobs" to put through; men whose "vaulting ambitions" will not lead them to use the county machinery to subvert political ends; men who will deal honestly and fairly by all classes and all interests, keeping a jealous eye upon the county's credit, and men who will carefully look the stable door before the horse is stolen.

Our choice for county commissioners will be found in the usual place for such announcements.

A LA MOREY.

Upon the very eve of the contest in Ohio, at a date when the effects of such a report could not be offset and the truth vindicated, that virulent sheet the Chicago Times came out with what it claimed to be fac similes of letters alleged to have been written by Mr. Blaine and Mr. Elkins concerning certain land and coal speculations in Ohio which Mr. Blaine has repeatedly said he had no connection with. It is a clear case of Morey letter over again, and is quite as mean a trick on the part of the Democracy as was that memorable fraud.

Mr. Blaine's signature to one of the letters is given with a great flourish and does not at all resemble his writing. The signatures to two other letters said

to have been written by Mr. Elkins are no more alike than the tracks of a cockroach are like the footprints of an elephant. Altogether it is a very awkward case of forgery. The date of its appearance, and the fact that the Chicago Times publishes it, are sufficient to condemn it. However, that class of Democrats who suck solace from the great blackmailing sheet of the West believe all that the Times has to say upon the subject and pine because it did not say more. When a man of Mr. Blaine's ability and reputation writes such sentences as the following every honest and upright citizen, north or south, will not permit a Times lie to cause them any doubt upon the subject. Before this forgery was uttered the Democratic literary bureau charged Mr. Blaine with being a member of a land and coal monopoly in the great Hocking Valley. The Republican Presidential nominee answered the charge briefly, without any evasion and to the point thus:

I beg leave to say that I am not and never have been the owner of any coal lands or iron lands or lands of any character whatever, in the Hocking Valley or in any part of Ohio. Nor have I at any time owned a share of stock in any coal, iron or land company in the state of Ohio.

It will require a more reputable concern than the Chicago Times to prove that James G. Blaine was lying when he wrote the foregoing lines.

The Democratic convention last Saturday was a peaceable and orderly gathering, and the proceedings were characterized by the absence of those disgraceful tactics which a certain alleged Republican convert has managed to introduce into previous political gatherings. The Republicans who attended the Democratic convention took no part in the affair. We trust that the Democrats will hereafter be as considerate and obliging.

HURRAH FOR OHIO.

She Rolls Up a Comfortable Republican Majority.

Three hundred and twenty-four wards and precincts out of 1892 in the state show a net Republican gain of 7317.

Five hundred and ninety-five wards and precincts show a net Republican gain of 9886. [These returns comprise nearly one-third of the state and indicate a Republican gain of 31,635. Hoadley's majority in 1883 was 12,529. This would give the Republican ticket a majority of about 19,000.]

Seventy precincts in Hamilton county show a net Republican gain of 3750. McKinley and Butterworth, Republican congressmen, are elected. [Cincinnati is in Hamilton county.]

Six hundred and forty-eight wards and precincts show a Republican gain of 10,245. Chase Brown is elected to congress in the Twenty-second Cincinnati district.

Seven hundred and seven wards and precincts show net Republican gains of 10,939. Foran, Democrat, is elected to congress in the Twenty-first district.

Seven hundred and sixty-eight wards and precincts show net Republican gains of 11,960.

Eight hundred and twenty-eight wards and precincts show net Republican gains of 12,620.

COLUMBUS, O., Oct. 15, 9 p. m.—Fifty-three counties out of 75 in the state show Republican gains of 19,974. Proportionate gains in the remaining 22 counties yet to hear from will make the Republican majority about 18,000. In 1883 Hoadley (Dem.) had a majority of 12,529.

So far as heard from the Republicans have elected nine and the Democrats seven congressmen, with five districts yet to hear from. Frank Hurd (Dem.) is defeated. [The present delegation stands 14 Democrats and seven Republicans.]

THE LATEST.

COLUMBUS, O., Oct. 16.—Official returns from Tuesday's election are coming in slowly at both state headquarters, and final estimates are made with difficulty on the figures received, subject to revision. The Democrats concede on the state ticket 10,637 majority, while Republicans estimate the majority at 10,792. The Democratic committee claim eleven of the twenty-one congressmen, while the Republican committee still consider the eleventh district doubtful and say it will require the official returns to decide. No figures are given on this district at either place.

WEST VIRGINIA.

The Democrats claim the election of Wilson, their candidate for Governor, by from 7000 to 10,000 majority.

A Kick from Minto.

Editor INTER-OCEAN: I noticed several of your articles on the situation and am glad you strike the right key note. Your allusion to Jud LaMoure capturing the Grafton convention was true. The pins were all set up some time before, when the Walsh county convention was called and the village of Minto sent two contesting delegations, one a regular Republican and the other a regular Democratic. When they went before the cooked up committee on credentials the regular Republican delegation was ruled out, although it contained the chairman of the Republican county central committee and also the member of the village committee. The other was composed of a lot of Democrats who were pledged to Grafton to do their dirty work and nominate a good Democratic ticket for the legislative convention, and as a consequence we had Pat McLaughlin, Pat McHugh and Jud LaMoure, a very good selection for a Republican to select from. The first two profess to be Democrats and have never voted the Republican ticket. The last named you know all about. The first two were put on the ticket to help Grafton along on the bonding of the county for \$20,000 for county buildings. They also put in the field Donald Stewart, a man after their own heart, and one whom they can use in their business. The Grafton meeting, or farce as it may be called, was attended by many Republicans, but Minto's delegation was thrown out when they were justly censured and backed up by fourteen affidavits that the meeting was called at the proper time and place by the Republican members of the village committee. The other meeting was called by Mr. Daley, a Blaine Democrat, or Oscar Wilder, as they are both alike in the Territory.

Feeling that the Republicans of the county could not get justice at the hands of the Democratic mob, we withdrew from the hall and immediately organized the regular Republican county association, and will place in the field Dr. Millsbaugh, of Golden Valley, for Council, and Mr. Kidder, of Forest River, for the Assembly, both good straight Republicans and fine men.

The "Krats" have had it their own way long enough. Let us organize and down them. We are thoroughly organized in Walsh county and we want you to help us to put respectable men before the people and not a lot of tools to be used by factions. We have time to get in shape if we work quick. Let us down the tools of the monopolists.
