

DEVILS LAKE IS THERE

REAL MEPHISTOS WILL PARADE THE STREETS AND LET THE PEOPLE KNOW.

DELEGATES FROM THIS CITY LEFT THIS AFTERNOON FOR CONVENTION.

Mephisto in all his glory was never arrayed like one of these. Such is the description that might be given the fire ladders when they make their appearance in Wahpeton to enjoy a three days session which starts tomorrow. The local delegates left today on N.

4, and they promise an eye opener when they arrive at Wahpeton. All will be attired in the suits of a real hooded animal of reddish hue and there will be nothing left out to make the costume complete and allow all the spectators to know where the boys came from. Thirteen, although an unlucky number, was the total of the delegates to the state meeting and from all accounts a big time is in store for them. The boys were chaperoned by Chief Russell and he promises not to stop them at any stage of the game in having a good time. A special train carrying the delegates from Minot and other places along the line will pass through Devils Lake this evening enroute to Wahpeton.

Every detail of the convention is complete and Wahpeton promises to outdo Devils Lake in the tournament which was held here two years ago.

RELATED TO MINOT MAN

WALTER TIERNY LOSES HIS LIFE IN BALD EAGLE LAKE NEAR "BOY ISLAND."

WAS SWIMMING WITH HIS BROTHER—BODY HAS NOT BEEN RECOVERED.

Special to The World: St. Paul, Minn., June 12.—Walter Tierney, a brother of Thomas Tierney of Minot and a former resident of Fargo, was drowned Saturday morning near "Boy Island," Bald Eagle lake, Saturday morning.

Walter was eighteen years old and employed by Foley Bros. & Kelly of this city. He was swimming with his twelve year old brother. Villagers of Bald Eagle, with the father, are dragging the lake but the body has not been recovered.

Young Tierney and his brother Clifford went to Bald Eagle Friday afternoon to spend the night and day fishing. They obtained a row boat early in the morning and rowed over to the island, where they fished for several hours. Tiring of this they took off their clothes and swam about the boat.

While diving from the boat, Walter evidently hit a rock or snag, for he did not reappear. Clifford dived several times and called, but could find no trace of him.

Almost frantic he rowed to the mainland and ran to White Bear village, a mile away, where he notified Dr. Chaise Clark, deputy coroner, who telephoned to the boy's father. Mr. Tierney left at once for the lake.

Walter Tierney was considered a good swimmer. Coroner D. C. Jones has received no word yet of the recovery of the body.

QUIET AND SERENE AT CITY COUNCIL

THOSE WHO EXPECTED-PYROTECHNICAL DISPLAY WERE DISAPPOINTED.

MOVING PICTURE SHOW LICENSE REJECTED—COMMISSION FORM UP.

The council rooms were crowded last evening at the adjourned meeting of the city council. If someone had announced an airship flight or a Fourth of July celebration but few more people could have been called out to brave the storm. Some thought there was a pyrotechnical display in sight, but there was not, for everything passed off smoothly and those who came to hear any stormy flights of oratory went away sadly disappointed.

It was a meeting of rejections. The matter of oiling the streets was considered unadvisable. The request of the school board asking that street irregularities be fixed so that improvements could be made to the school grounds was delayed until next Tuesday so that the improvement committee of the council could investigate and report and the matter of granting a license to run a moving picture show to Messrs. Lyons and Doty, which passed favorably last Monday evening, was re-considered and rejected. In addition to this the commission form of government was delayed until another petition is forthcoming, the petition presented having been misplaced. Furniture for the council chambers was the last thing up for consideration.

OILING STREETS. City Auditor Jones announced before the start of the meeting that there would have to be another meeting next Tuesday night to select more jurors. The matter of oiling the streets was reported on by Alderman Halgrim, due to the absence of Chairman Newgard of the street committee. A communication from the city auditor of Larimore was read and proved unfavorable to the proposition. Committee reported it unadvisable, due to insufficient funds. Alderman Wineman stated that it was hard on tires and in wet weather was worse than the streets are now. Alderman Miller stated that in view of the fact that gutters were to be installed that oiling the streets at this time he would not consider advisable. Alderman Callahan thought that if it was a good thing it would be more generally used in places of this size. On motion of Alderman Hanson the report of the committee was adopted.

FIRE HALL. The committee in charge of the plans and specifications for the fire hall were not ready to report, the plans not being completed, and requested that another week be allowed, the request being granted by the council with the hope that this matter would not be delayed further, in order that the work might be commenced at once on the fire hall.

George W. Mooers, president of the school board, appeared before the council requesting that irregularities on the school block be fixed, which necessitates the city to deed a strip of land to the school board and the school board another strip to the city in order to make Eighth street uniform and allow the school board to make improvements on the ground. Mr. Mooers was anxious to get the matter settled at once so that work could go on and it could be passed on by the school board at its meeting next Tuesday evening. The matter was passed on favorably by the council two years ago but the school board was not ready. Inasmuch as the new members of the city council were not familiar with the proposition it was referred to the improvement committee to report next Tuesday night.

THE LICENSE QUESTION. Alderman Miller took the initiative moving that the council reconsider the action taken Monday night in the granting of a license to Messrs. Lyons and Doty to operate a moving picture show. The motion was seconded by Alderman Johnson. The ordinance regulating the matter of re-consideration was read in order to ascertain whether it was beyond the power of the council to reconsider, but inasmuch as it was an adjourned meeting, the continuation of the meeting of Monday night, City Attorney Cuthbert held that the motion was proper. The matter was then opened for discussion and Mr. Lyons was given the floor. He stated that he had talked with Mr. Gram, owner of the opera house and agreed that at any time the present managers wanted to give up the lease he would lease the opera house at the same rental the present managers are paying, or he would lease the house in January when the present lease expired, if Mr. Gram felt any danger of it being closed up.

Mr. Gram was called upon to present his side. He stated that it was not necessary for him to go into any detail as to how the opera house was secured except that he had every cent of his money in the building and it was a struggle for him to keep going and pay taxes. With a hard year he said everything was against him. He said that in order to get the opera house the city council and Commercial club promised everything to assist him. Referring to the offer of Mr. Lyons he said that the offer had been made, but that had been

done several times before and failed and that he felt sure somebody would rent it for any other purpose. He said that with two shows someone would go "bump." Alderman Turner asked Mr. Gram if he got a guarantee from Mr. Lyons if that would be satisfactory and Mr. Gram said it would. Alderman Callahan said that one good horse was better than two crippled ones. Alderman Hanson thought that inasmuch as Dr. Hocking and Mr. Moran were turned down on this same proposition by the council four months ago that the plan should not be changed now. Alderman Wineman commented that the old-timers were always turned down. Alderman Miller said that when he voted favorably on the granting of the license Monday evening he voted on the idea of equal rights to all and special privileges to none, but he found that ninety per cent of the people had the opposite opinion and he figured his vote was wrong and he should consider the rights of the majority. It was not because he had any fault to find with Mr. Lyons or Mr. Doty or because he favored Mr. Gram, he being of the same political belief.

Alderman Turner at this juncture asked Mr. Gram what guarantee he would give that the opera house would not close anyway. Mr. Gram stated had given every dollar to Devils Lake in investing in the opera house and he could not give any more. Alderman Turner suggested that it was "a horse apiece."

THE VOTE. The vote on re-consideration was then taken. Alderman Wineman, McGurken, Johnson, Harris, Callighan, Miller and Hanson voted aye and Alderman Green, Turnes, Halgrim and Ohmstad, no. Alderman Newgard being absent, the result being 7 to 4. Alderman Johnson moved that the application for license to Messrs. Lyons and Doty to operate a moving picture show be rejected and on roll call the same vote prevailed, and the application was rejected.

COMMISSION FORM. Attorney Cuthbert was called upon to report on the petition for the commission form of government. Mr. Cuthbert said: "I suppose the public will ensure me, but regardless of that I must say that somewhere in the universe I suppose there is such a thing as that petition, but I have to say that I have ransacked my office and I cannot find it." Mr. Johnson interrupted and asked if he had searched his former office. Mr. Cuthbert stated that he had and said further: "I regret that I am unable to find it, but I assure the council that I am not small enough to attempt to hold up the matter, nor could I do it if I so desire and while I am personally against the commission form of government I would do everything in my power to locate the petition." Mr. Johnson was appointed a committee to assist in the hunt and accepted. Mr. Cuthbert then said: "I trust that you are charitable enough if it requires any charity, to think that I would not do anything that would in any way hold up this matter." Alderman Miller stated that the people forwarding the movement would not have any such idea and that it would be easy to misplace the document. Alderman Wineman suggested that those forwarding the movement present another petition to the city council as soon as possible.

The last thing considered was the matter of purchasing furniture for the council chambers, such as individual desks, and it was decided to call for bids. With this the council adjourned to meet again next Tuesday night.

STAR FLINGERS ARE FOUND. Duke Farrell Says Johnson and Mathewson Are in Rusie's Class.

Duke Farrell, the old catcher who coaches the Yankee pitchers, says Walt Johnson and Christy Mathewson have as much speed as Amos Rusie had, and there are three or four pitchers in the American League as speedy as Rusie was. Farrell was Rusie's catcher. "Rusie didn't depend on his speed," said Farrell. "He had wonderful control and a good curve ball. Any pitcher who has speed and control with it should win most of his games. Rusie won by mixing his great curve with his speed. He could put the ball where he wanted it." "Rusie used a slow ball once in a while too. A pitcher with a world of speed ought to have a good slow ball. Batters step up quick against a pitcher who has lots of speed, and if he uses a slow ball once in a while he can catch the batters completely off their balance." Walter Johnson would be a much greater pitcher if he had better control. I don't mean that Johnson is a wild man, but his control is nothing out of the ordinary.

Mathewson looks like a perfect pitcher. He has speed, control, a slow ball and the fade-away. Along with all that he has a fine head." Farrell is a regular old dude. He is the only man in the league who carries a cane. He wouldn't even go from his room to the hotel lobby without his cane. "I've carried a stick so long I'd be lost without it," Duke said.


