

The hot metal was thrown over Mr. Erickson's body and into his eyes and his injuries as a result are very bad.

TURTLE LAKE FARMER NARROWLY ESCAPED WITH LIFE—IS BADLY CRIPPLED.

Turtle Lake, N. D., Sept. 8.—Fred Mellin, a well known farmer living northwest of town met with a serious accident Tuesday noon of the week, which very nearly cost him his life and will leave him a cripple for some time.

While raking just before turning out for dinner one of his horses lay down on the tongue of the rake and broke it. During the mix up, Mellin was jerked from his seat on the rake and dragged down among the plunging horses. His foot caught in the rake some way and the fall broke his right thigh. The standing horse kicked him and broke three ribs on the left side. The team then ran away and dragged him several rods, bruising his body and face. His son, who was driving in with a load of hay, saw his father's danger and ran to the rescue and his team ran away to two neighbors, Walter Beggs and Halvor Knutson, happened to drive along at this time and assisted the boy to get his father home. Dr. Paulsen of Turtle Lake was called and the broken limb immediately set and the other wounds cared for.

PLAINTIFF CONTENTS THAT THE NORTH SIDE MINOT SITE WAS NOT LEGALLY SELECTED.

Minot, N. D., Sept. 8.—Contending that the North Side site has not been legally selected and that money expended for advertising for bids, surveying of the grounds for the architect and other expenditures of money for the building of a normal school on the Ramstad site on the North Side, is an illegal expenditure of the state's money, Frank W. Youngman has started an action against the Normal board of control, and an injunction was served on the members of the board at their meeting in this city this afternoon, restraining them from expending any of the state's money in laying out of grounds, advertising for bids, or anything else in connection with the erection of the institution on the North Side site. Attorney E. B. Sinkler and J. A. Heider are several of the attorneys for the plaintiff. Funds for carrying on the legal battle, which promises to be the most interesting ever waged in the northwest, and for which there is no precedent anywhere in the entire United States, are provided by prominent south hill people. Mr. Youngman, who is named as plaintiff, is but one of the interested parties.

While it was generally believed that with the election of a site held by the Minot people several weeks ago, and the subsequent selection of the Ramstad site by the Normal board at Valley City, would settle the matter for all time, it has been known for some time that a fight was brewing. The details of the selection of the North Side site were very meagre and in order to satisfy themselves as to the action taken by the board, Attorney Heider, was sent to Bathgate where a transcript of the records of the Normal board was secured. Upon Mr. Heider's return, a consultation of all the attorneys and the interested parties was held and the records were very carefully discussed with the action which has been begun in the injunction resulting.

SENATOR JOSEPH BAILEY IS NOT A CANDIDATE FOR THE JOB AGAIN.

Fort Worth, Tex., Sept. 8.—The Record of Galveston, Tex., announced that United States Senator Joseph W. Bailey will not be a candidate for re-election.

"I will not be a candidate for reelection to the senate next year and this decision is irrevocable," Senator Bailey is quoted as saying.

Senator Bailey declined to assign reasons for his determination not to seek re-nomination.

TOOK OWN LIFE.

St. Paul, Minn., Sept. 8.—With an uncompleted letter in his pocket, in which he pleaded with a young woman whom he called "Leda" to give him another chance, Lyman Genewin, 25 years old, of Hazel, N. D., went to a vacant lot at Second avenue south and First street, Minneapolis, last night and took his own life.

His body was found early today in a cluster of weeds by Patrolman Jonas Jonasson. Beside the body was a revolver with one empty chamber.

The body was taken to the morgue and relatives have been notified.

# Poker Game at Lakota Ends In Stabbing Fray in Which One Man is Badly Injured--Confined to Hospital Here

## Hallie Langhoff Suffers Two Deep Gashes in His Left Side, Opening Up His Body so that Internal Organs are Left Exposed--One Gash is Eight Inches Long--Colored Man Accused of the Crime--Is Held at Lakota

A poker game which ended in a stabbing fray occurred at 4:15 o'clock Saturday afternoon at Lakota, resulting seriously for Hallie Langhoff who is confined to the Mercy hospital in Devils Lake suffering two deep gashes in his left side from which he may not recover. A colored man, his name unknown, is held at Lakota awaiting hearing on a charge of attempted murder.

The condition of Langhoff, who is at the hospital here, makes it almost impossible to get the exact details of the affair, but stories are somewhat conflicting. Langhoff has not been in Lakota very long and where he comes from cannot be ascertained, although it is said by some that he followed the game to some extent, in which he was engaged when he met with injury.

SCRAP OVER CARDS.  
From what can be learned Langhoff, the colored man accused of the crime, and two others were engaged in a poker game on Saturday afternoon. On the hand which resulted in a quarrel Langhoff held two queens, while the colored man had a pair of aces. Langhoff did not take the loss of the pot and his defeat very graciously and he accused the colored man of cheating. The argument grew heated and threats were made by the colored man, Langhoff finally picking up the cards in which he was sitting and cracking the colored man over the head.

CONFLICTING STORIES.  
According to Langhoff's story the colored man assaulted him with a knife into the abdomen and the lower edge of the lung, opening him up in such a manner as to leave a portion of the internal organs exposed. The other gash

Langhoff went out into another room preparatory to leaving the building and as he reached for his hat, the colored man crept up to him, assaulting him with a knife, cutting two deep gashes in his left side.

TRIED TO ESCAPE.  
The colored man tried to escape and ran for the depot pursued by the crowd. He endeavored to board train No. 6, which was just ready to pull out of the Lakota depot, but he was halted by Engineer Green of Grand Forks, who was standing on the platform of the smoking car and noticed the blood stained knife which the colored man still carried in his hand.

"Hold him, don't let him on the train" were the cries that Mr. Green heard from the pursuers of the colored man and with a little assistance he managed to grab the colored fellow and evade the knife which the nigger threatened to use. It was more excitement than Lakota has witnessed for years and it was not without difficulty that the colored man was taken to the jail to await hearing. He will probably be taken to Grand Forks where he will be put in the county jail for safe keeping.

LANGHOFF'S CONDITION.  
Langhoff was hurried to Devils Lake on the next train and taken to Mercy hospital in this city where he now is in a serious condition, although somewhat better today than yesterday, when he suffered considerable pain.

The most severe gash on the left side is eight inches in length, the cut being into the abdomen and the lower edge of the lung, opening him up in such a manner as to leave a portion of the internal organs exposed. The other gash

just below is about two inches in length, through the skin and into the muscles.

NOT KNOWN WELL.  
Hallie Langhoff is a married man, his wife having called here yesterday to visit her husband, returning to Lakota this morning. He has not been in Lakota very long and is not very well known there. From where he came is not known. His love for the game which brought on his injuries, it is reported by residents of Lakota, is the main business pursued by the injured man. The colored fellow is also an unknown at Lakota.

HOLD UP HEARING.  
States' Attorney Skulason, late this afternoon, decided to hold up the preliminary hearing of the colored fellow at Lakota to await returns of the condition of Langhoff, who is at the hospital here. It is thought that perhaps the injured man may die, which would mean a charge of murder, whereas, if the fellow lives the charge will be assault with a dangerous weapon with intent to kill.

From all accounts Langhoff is a resident of southern Minnesota and is an engineer on a threshing engine, although he has not been following that vocation since arriving in Lakota. The colored man's name is Frank Alexander and he is a resident of Washington, D. C.

The affair occurred in what is known as "the jungles" at Lakota, across the Great Northern track.

States' Attorney Skulason will prosecute the case and Attorney John J. Samson of Devils Lake has been engaged to defend Freeman Alexander.

Minot, N. D., Sept. 9.—August Johnson, accused of shooting and killing John Gash near Rice Lake Monday afternoon, must face a jury in the district court and answer to a charge of murder in the first degree, the penalty of which is death or a long term in prison.

Johnson appeared before Judge Murray for preliminary hearing and after taking the evidence of Dr. Titus, Mrs. Gash and Sheriff Ed. Kelly, all for the state, the police magistrate decided to hold the accused to the district court.

The defendant will be represented by Attorneys LeSueur, Noble, Blood & Adams.

The coroner's jury, composed of L. P. Bierly, A. P. Scofield and H. E. Byrum, holding an inquest yesterday afternoon, decided that Gash came to his death through a gun shot inflicted by Johnson.

Johnson seems to have no thought of the seriousness of the crime with which he is charged. The proceedings held thus far have failed to move him. Following the hearing this morning he shuffled up the street with Sheriff Ed. Kelly in a most unassuming manner. The alleged murderer is about 35 years of age. He is short of stature and unkempt in appearance. His hair and mustache are light and untrimmed.

It is said that the defense will be temporary insanity or self defense.

The crime for which Johnson will be charged will be the shooting of John Gash on the latter's claim near Rice Lake, the trouble having started over a land deal. According to testimony Gash went to Johnson's sod hut on Monday afternoon for the purpose of having a settlement, words ensued and it is alleged that Johnson shot Gash with a ten gauge shot gun and that Gash immediately thereafter died from the wounds.
