## WRESTLER WHO IS NOW HERE WILL HAVE A MATCH WITH PERSON SOON.

Grand Forks, Dec. 8.—A letter was received a short time ago from Chris Person in which the Duluth wrestler asked for information on the prospects of another match in Grand Forks. Person gets his chance. Farmer Jahns and his manager, Al. Powers, have been interviewed and are ready for the match any time the conqueror of Ole Hauge and Doran wants to come to the city.

A letter has been sent to Person and it is expected that he will be in the city sometime within the next two weeks ready to take the farmer on. While no definite date has been set for the match it is understood that it will be pulled off sometime before Christmas.

Moe, the 230 pound wrestler of Christine, N. D., is also on the correspondence list of local promoters and it is expected that he will have a chance to show what he is good for some time about the Christmas holidays.

## MAN WHO TOOK BLANKS FROM POSTOFFICE HERE ENTERS PLEA AT ST. PAUL.

St. Paul, Dec. 8.—Charles Ferguson, alias John J. McAnn, who was arrested on September 2 at Mankato, Minn., charged with forging postoffice money orders, pleaded guilty to the charge yesterday afternoon in the United district court before Judge Charles A. Willard.

The federal grand jury, late in the afternoon returned an indictment against him, and as soon as the circuit court was adjourned he was brought before Judge Willard.

Ferguson is said to have stolen a book containing 130 blank money orders from the postoffice at Devils Lake, N. D., last August and to have had a special stamp made with which he stamped the money orders after forging the postmaster's name. Those filled out by Ferguson were said to amount to more than \$1,300. Orders amounting to \$400 were sent to Tiffany, New York; orders amounting to \$200 to Loftus Bros. & Co., Chicago; one to the Howard Watch Co., for \$100 and many of smaller amounts to other jewelers.

Loftus Brothers & Co., after accepting the money orders from Ferguson, became suspicious and notified the postmaster, who at once recognized them as forged, and Inspector A. E. Germer was sent to St. Paul, as it was from here that the orders were sent. After a twenty-four hour chase Ferguson was arrested at Mankato, where he had ordered his mail forwarded.

## THE BOARD TOOK ACTION ON IMPORTANT CRIMINAL CASES YESTERDAY.

Bismarck, N. D., Dec. 8.—The state pardon board took action on three more important criminal cases yesterday.

Joe Remington, convicted in Cass county of a brutal murder in 1891, sentenced to life imprisonment, had his sentence reduced to thirty years and he will soon be free.

James Kelly, sentenced from Traill county for the murder of Policeman Paulson at Mayville, had his sentence reduced to twenty-six years and he soon will be freed. He was convicted in 1894. William Long had already been freed, being convicted in the same case.

William Poe, formerly city auditor of Williston, was granted a conditional pardon. He was sentenced to ten years in 1909.

## THIRTY-SIX HUNDRED VOLTS ENTERED HIS BODY AND HE WAS KNOCKED TO GROUND.

Butte, Mont., Dec. 8.—A. G. Morrison, a lineman for the electric company, was killed here this morning while attending to his duties on the pole. He received 3,600 volts through his body and was knocked from the pole to the ground. He died in an automobile while being hurried to a hospital.

## MOST SUCCESSFUL GATHERING HAS BEEN ON IN MINNEAPOLIS THIS WEEK.

Minneapolis, Minn., Dec. 8.—One of the most successful meetings of the Minnesota State Horticulture Society will terminate today after being in session in Minneapolis since Tuesday. The society promises to make a creditable display of apples at the Northwestern Land Show to be held in St. Paul Dec. 12 to 23.

## FORMER RESIDENT OF DEVILS LAKE DIED AT MILES CITY, MONTANA.

J. G. Remfrey, a former resident of Devils Lake and at one time prominent in musical circles here, is dead. He will be remembered by many. The following account of his death is taken from the Grand Forks Times:

J. G. Remfrey, formerly a resident of Grand Forks and East Grand Forks, is dead. His remains were taken to Mineral Point, Wis., his birthplace, interment taking place there last Saturday, death occurring at Miles City, Mont.

Mr. Remfrey was 53 years of age at the time of his demise, and death was due to kidney trouble, with which he had been troubled about a month.

He is survived by a wife and four sons, Glen, Albin, Leon and Curtis, all residing in Grand Forks. Mr. Remfrey was well known in Grand Forks as a musician and took a prominent part in band work, being at one time director of the East Grand Forks organization.

## REV. SHAW PASSED THROUGH THE CITY ON RETURN FROM FUND RAISING TRIP.

Rev. E. S. Shaw of Minot, who is in the city Friday, has been making a trip in the state in the interests of the \$12,000 mission fund for the Congregational churches of the state.

He is returning today from a trip to Wahpeton, Fargo and Grand Forks, where he was in consultation with some of the leaders in church work in the state with reference to a campaign which will be inaugurated with the beginning of the new year to raise \$12,000 in the Congregational churches of the state for missions. This is a part of a nation wide movement recently started to secure an annual increase of \$2,000,000 for missionary work in the world. It is an effort to systematize the giving and simplify the appeal by appointing the entire amount to the churches of the denomination on the basis of membership—taking into account ability as indicated by local expenditures and dispositions as indicated by past gifts. A committee of the state conference consisting of Rev. E. D. Gallagher of Wahpeton; Rev. A. Hitecock of Hope and Rev. W. K. Bloom of Williston is making up the apportionment for the churches of North Dakota which will be sent out so as to be in the hands of the local church Dec. 30th to be presented to the congregations the last Sunday in the year.

The plan contemplates securing if possible a gift from every member of the church and congregation to swell the total, contributions from the Sunday schools, Young People's societies and Women's organizations will be counted on the amounts apportioned to the local church.

The state conference has pledged \$3,000 for the work in Grand Forks in recognition of the importance of the work in relation to the student body in the state university. Money designed for this purpose will be sent through the regular channel and so designated. Mr. Shaw, in connection with his work as Assistant Superintendent, will visit the churches as far as possible and assist in raising the amount.

## EGGS SELLING AT FORTY-EIGHT CENTS AND BUTTER AT FORTY-THREE CENTS.

Chicago, Ill., Dec. 9.—The prices of food stuffs go up. Eggs are selling at forty eight cents a dozen and butter at forty-three cents a pound.

## JOHN HARRIS WAS CLEARING GROUND—BLOWN TWO HUNDRED FEET IN THE AIR.

Libertyville, Ill., Dec. 9.—John Harris, a young man working on a farm near this city, set fire to an old stump this morning while at work clearing off a piece of ground and was blown 200 feet in the air by the explosion of a charge of dynamite which had been concealed in the stump. Although he is severely injured he still lives.


