PIPE PRICES SOAR.

BLACK STEEL AND GALVANIZED LISTS SHOW BIG ADVANCE.

Pittsburg, Pa., March 21.—An advance in the price of black steel pipe from \$2 to \$6 a ton by the lowering of discount from 1 to 3 points was effected today by the leading pipe manufacturers in the Pittsburg district. The increase affects all standard sizes

up to and including twelve inches in diameter.

Changes of galvanized pipe within the same size range from \$3 to \$10 a ton, the advance being guarded according to the size affected.

New prices also are issued for all country goods, such as tubing, casing and drive pipe, which advanced prices from 2 1/2 to 5 per cent.
