NOTICE TO DESTROY NOXIOUS WEEDS. At a meeting of the Board of County Commissioners held May 19th, 1916, the date for the destroying of noxious weeds in accordance with Sections 2817, 2818, Compiled Laws of 1913, which read as follows:-- "2817. Noxious weeds, manner of destroying. Each person shall destroy upon all lands which he shall own or Canada thistle, cocklebur, mustard, wild at such time and in such manner as shall effectively prevent their bearing seed, and it shall be a misdemeanor for such person or persons to deposit or in or along the highway or water course any of the noxious weeds above described, and such misdemeanor shall be punishable by a fine of not more than fifty dollars nor less than ten dollars. The time and manner of destroying such weeds shall be prescribed by the board of County Commissioners, and the same shall be published at least two weeks in some newspaper of the county, not less than two weeks before the time so prescribed; and if there is no newspaper published in the county, then written notice of the same shall be posted, in lieu of such publication, on the 28th day of May, 1916. Decision to be published. It shall be the duty of the board of County Commissioners, at its regular meeting, the time and manner of destroying such noxious weeds, and such decision shall be published as provided for in the last section. It shall also cause board of township supervisors of each township to cause the same to be mailed to each overseer of highways and road supervisor in the county, a copy of its proceedings."
