CANADIAN WHEAT COMING IN.

Wheat in Pembina was \$2.75 cents the other day while at Emerson it was \$1.92. In consequence of this difference there are hundreds of bushels crossing the line to the American markets daily. In order to bring it across the owner of the grain must have a permit from the board of trade at Winnipeg, which we understand is easily obtained. And the wheatbuyer on this side must have a permit from the Federal government to buy Canadian wheat.

Mr. Shannon of the Victoria Elevator Company is the only one in Pembina who has such permit at the present time and he is receiving a great quantity of Canadian wheat. Only 25,000 bushels are allowed to be imported on each permit but these permits can be renewed at any time the applicant makes a request to the authorities at Washington. For several months the Canadian markets have been considerably below the American markets, but this is the greatest difference we have had since the McKinley bill was in force when Canadians had to pay a heavy duty to bring in their wheat to the United States to compete with the American farmers.

We saw a party from Dominion City the other day who said he was preparing to bring over daily three team loads of wheat as soon as he received his permit from Winnipeg. He said he knows of many of his neighbors who will do the same. He said it will make a difference of \$1,000 in what wheat he has left in the bin.

NEW RURAL ROUTES.

Steps are being taken to establish two new rural mail routes out of Pembina. One will follow the Red river and take in the McArthur country while the other will reach southwest to the neighborhood of James Meagher, Carivau and Trudel neighborhoods, going west via Geo. H. Morris. A good deal of this territory has not been covered by delivery service in the past and now that the McArthur post office closed it is very inconvenient for those people to get their mail. Many of them take daily papers that are a week old when the mail reaches them. The railroad mail service at Pembina is probably the best of any city in this part of the country. The Northern Pacific gets here in the evening and the Soo and Great Northern mails at Noyes five o'clock in the morning. The Winnipeg mails gets here at ten in the morning. Besides the Hamilton star route in the afternoon.

All these trains are daily including Sunday. The Soo and the Great Northern brings all the Twin City mails on Sunday that the N. P. morning train distributes south as far as Johnstown. The Sunday mail over these routes for the Pembina post office to be distributed south is often a wagon load. And these trains carry mails from here south in the evening.

The deer and moose season opened in Manitoba on Monday last and the Emerson sports are out east in the vicinity of Lake of the Woods, on the Canadian side of the line trying their luck. It used to be that there were plenty of big game thirty miles east of Emerson but settlement has driven them farther east along the Canadian Northern between Winnipeg and Warroad. Reports from there before the season opened were that deer were quiet plentiful but the moose is getting scarcer every year.

In our issue this week, you will find an attractive department on the subject of Christmas presents the children can make at home.
