Will Lead Mercer County Democrats at Campaign Opening on 15th.

At a meeting of the Democratic Executive Committee, held at the office of Secretary Haysbaugh last Monday evening, it was decided to open the campaign in this county a week earlier than at first set, and the committee finally decided on Saturday, October 15, a week from to-morrow.

Yesterday afternoon Chairman Johnson received word from Hon. John J. Lentz, of Columbus, candidate for United States Senator, an order of recognized ability and not afraid to state his attitude upon public questions, that he would heartily give Mercer County Democrats his services for the day and evening.

**Rockford to Hear Lentz**  
With this information at hand the Executive Committee yesterday afternoon arranged to hold two opening meetings on the 15th, Celina dividing honors with Rockford, using Mr. Lentz at both places, with the addition of other speakers.

Hon. J. Henry Goeke, of Wapakoneta, candidate for Congress, and Hon. Phil M. Crow, of Kenton, candidate for Circuit Judge, have been written to, and it is expected to have these gentlemen to complete the oratorical features of these opening meetings.

Mr. Lentz will speak in this city at 2:30 in the afternoon on the date named. At the close of the afternoon rally here he will be conveyed by automobile to Rockford, where he will address an evening meeting at 7:30.

Small Lad Frightfully Wounded by Boys, Who Make Plea of Accident.

Rough House Started During Chattanooga Dance, Result of Booze.

Carl, the seven-year-old son of Squire and Mrs. George Leininger of Liberty township, was shot through the left cheek by Andy Fickert, while in an out-house on the school grounds, a mile south of Chattanooga, a week ago yesterday. The shot penetrated the left cheek, passing entirely through the fleshy part and coming out near the nose.

The Fickerts live near the school-house, and Andy, together with his brother Gus, were digging potatoes in a field adjoining the school ground, when the shooting occurred. Twice during the afternoon Teacher John Pifer had ordered them to leave the school ground when he caught them pointing a Winchester rifle at the school children.

The young Leininger lad had been excused from the school-room, and as entered the out building Andy Fickert fired two shots, one of them taking effect as stated. Pupils saw the little fellow staggering towards the school-house and called the teacher's attention to the matter. He immediately went to the assistance of the lad, and when he found he had been shot he had him taken home. Mr. Pifer called to the Fickert lads, but they ran for home.
