A resolution endorsing President Wil-  
 son's preparedness program was voted  
 down, 68 to 57, in the lower house of the  
 state legislature today, while another, ex-  
 pressing confidence in the president, was  
 unanimously adopted.

By a vote of 281 to 81 the lower house  
 of Congress Tuesday passed the good  
 roads bill authorizing the appropriation of  
 \$25,000,000 to extend federal aid in the  
 construction of rural postroads.  
 That is the kind of preparedness that  
 is worth while. Only they should have  
 made it a \$100,000,000 or more.

Republican papers are much worried  
 about President Wilson changing his  
 mind and now favoring a non-partisan  
 tariff commission, made up of business  
 experts to take the tariff out of politics.  
 Standpatners never change their opin-  
 ions—they are too rheumatic and par-  
 alyzed to move. But it becomes them.

President Ripley of the Atchison Rail-  
 road is still grumbling over the failure of  
 the government to do anything for busi-  
 ness. Otherwise the only grumbling now  
 heard in relation to the railroads is over  
 their own failure to do anything for the  
 business which wants to move and can-  
 not.—Columbus Times.

Hon. Frank W. Miller, State School  
 Commissioner has resigned to accept the  
 superintendency of the Dayton schools.  
 Dayton is his home city. His present  
 salary is \$4000. His new salary will be  
 \$2000. His leaving the state service will  
 be regretted. He is a Democrat. He has  
 been remarkably successful as head of  
 the public schools of Ohio.

Sentiment exists among Democrats of  
 the state for the choice of Newton D.  
 Baker, of Cleveland, as a member of the  
 at-large delegation from Ohio to the De-  
 mocratic National convention. Mr. Baker  
 has expressed no desire in the matter but  
 it has been announced that Cleve-  
 land Democrats expect to send the former  
 mayor as a district delegate. His friends  
 throughout the state, however, feel that  
 it would be more fitting that Mr. Baker  
 should be one of the delegates-at-large,  
 representing all the Democracy of the  
 state, because they look upon him as one  
 of the leading Democrats of Ohio and  
 wish to do him honor, and because of the  
 fact that none in Ohio are closer in rela-  
 tion to President Wilson than is he.

Newton D. Baker has been of service to  
 the people and to his party in this state.  
 Honor ought not bestowed upon him  
 could only be accepted by him as a mark  
 of appreciation and expression of confi-  
 dence.  
 Four delegates-at-large are to be cho-  
 sen. While numerous prominent men have  
 been talked of in connection with the se-  
 lections there has been an attempt at  
 state making. Whoever may be chosen  
 they will be from a list of Democrats  
 who will do the state honor.

**BLOOD-THIRSTY ROOSEVELT**

Theodore Roosevelt's solution of the  
 Mexican trouble is to dispatch General  
 Leonard Wood with an armed force into  
 Mexico forth with. This is characteristic  
 of the man. His remedy for massacres  
 of innocent people is the massacre of  
 more innocent people. His remedy for  
 lawless outrages is lawless outrage. Gen-  
 eral Wood with his armed force in Mexi-  
 co could not identify the actual assassina-  
 tion of the Americans and inflict just pun-  
 ishment upon them. He could not, of course  
 restore the murdered Americans to life.  
 Then what just and reasonable purpose  
 could General Wood and his army serve  
 in invading that wretched and unfortu-  
 nate country? The people of Mexico have  
 not wronged the people of America. Then  
 why should we send a military force to  
 shoot them into the Roosevelt idea of law  
 and order?

Mr. Roosevelt positively, and with the  
 emphasis of supreme and indisputable  
 authority, declares with tears in his voice  
 that "this dreadful outrage is only an in-  
 evitable outcome of the policy that has  
 been followed in Mexico for the past five  
 years and above all for the last three  
 years." The killing of 17 American ex-  
 patriates—men who abandoned their na-  
 tive land to exploit a foreign land—over-  
 whelms with unspendable sorrow a man  
 who when commander-in-chief of our  
 American army commanded at the issuing  
 of an order in the Philippines by one of  
 his subordinates, "Hell Roaring" General  
 "Jake" Smith, to kill all over 10 years of  
 age. What is the killing of 17 American  
 adventurers who were repeatedly warned  
 to keep out of Mexican territory where  
 lawless conditions were known to exist  
 to an order to American youths to kill  
 all over 10 years, regardless of sex or of  
 condition? What can be expected of a  
 young American who must stolidly and  
 without protest obey such an inhuman  
 order? His God-given right to reason is  
 denied him. The brave soldier at least is  
 destitute of the noble qualities and gener-  
 ous impulses that constitute a man. A  
 brave soldier is not necessarily a brave  
 man. A brave man would die before he  
 would obey an order to kill innocent  
 women and children, but a brave soldier  
 must petrify his conscience.—Johnstown  
 Democrat.

Practically all steel workers in the U.S.

French government orders \$2,000,000 of  
 steel rails in U. S.  
 New York, Jan. 20.—The Bethlehem  
 Steel corporation, which is said to have  
 received orders from the entente allied  
 governments for ordnance and other war  
 supplies amounting to more than \$200,-  
 000,000, declared the first dividend in its  
 history today on the common stock. The  
 distribution amounted to \$20 a share, or  
 a total of about \$41,500,000.

New York, Jan. 25.—United States Steel  
 common shares were restored to their  
 regular dividend status of 5 per cent. to-  
 day, when the directors unanimously de-  
 clared a quarterly disbursement of 14  
 per cent. out of earnings for the last  
 quarter of 1915. Total earnings of \$31,-  
 217,788 for the three months were the  
 highest for any similar period in the  
 history of the corporation, exceeding the  
 previous record, made in the second  
 quarter of 1907, by \$5,729,983.

There are 162 dreadnoughts in the  
 world and their total cost is \$2,430,000,  
 000. What a lot of money devoted to  
 killing people in national quarrels! What

 nature, agriculture, good roads, good fel-  
 lowship and wholesome exercise. That

 dreadnoughts, costing two and one half  
 billion dollars, and other war craft beside  
 and we have on hand the biggest war in  
 history. And then to think everybody is  
 building more dreadnoughts and the whole  
 world has been seized by the mania for  
 fighting worse than ever. God pity us  
 all.—Ohio State Journal.

**ETERNAL VIGILANCE**  
 Friends of workmen's compensation are  
 warned to be on the watch in every  
 county. The old Equity association still  
 lives and it is still working. Fearing to  
 operate under the friendly ruling of the  
 state insurance superintendent the em-  
 ployer's liability insurance companies  
 have perfected a new political organiza-  
 tion through which they hope to control  
 matters in connecting with the makeup

of state tickets next fall. They espe-  
 cially hope to gain control of the legisla-  
 ture and they are especially opposed to  
 the re-election of James M. Cox. The  
 slogan sang that workmen's compensation  
 is safe from attack is being used and  
 prospective candidates on both Republi-  
 can and Democratic tickets are told that  
 it is no longer necessary to interest them-  
 selves in this matter. It may be well for  
 the people to remember that "eternal vi-  
 gilance is the price of safety" and give  
 candidates thorough inspection who belit-  
 tle the necessity for remaining on guard.

**STOP, LOOK, LISTEN**

 This country had better pay attention to its own militarism rather than be so deeply concerned about Germany's. To illustrate—in 1879, when Grant was president, the entire appropriations for West Point amounted to \$116,000. Now it costs \$2,500,000. Great stride toward militarism is found in these figures. Again, it costs \$4800 a year to educate a boy at West Point, while he can attend Ann Arbor or any other college at \$48, which is the average rate. Then, as it is a military post, it costs \$50,000 a year to keep 150 soldiers on guard there. There is an item of \$24,000 for music; and \$4000 for flowers and \$400 for waxing the dancing floor. That is the way militarism is treating the patient, hard-working citizen of this glorious free republic. These figures we take from a speech made in Congress by General Sherwood of Toledo.

**CORN BOYS SUFFER FROM POLITICS**

Frank Willis told Frank Miller to let the Boy's corn growing contest alone. Willis insists that his political crowd shall run the show. He and his politicians have well nigh ruined the movement. There remains \$5000 in the state treasury to promote this game in 1916. When Miller, the head of the state school department, publicly announced that he would take charge of the contest, public sentiment everywhere was with him and the newspapers were with him. Evidently the wrecking crew feared that Miller would make a success of it. Willis and his political bunch made a pure political junket out of it in 1915. Black and white politics were played at the expense of the cause. Boies Penrose, the republican boss of Pennsylvania, was of more importance than the corn boys. Governor Willis was glad to have arrangements made to meet Penrose at Philadelphia and let two bosses look at each other. Willis interfered with contracts made in the corn trip program, in saying that the boys should not see

the famous picture show, known as the "Birth of a Nation." A few colored politicians made a kick, and the Governor was at once ready to disappoint the boys who had won a victory in the corn field to please a few voters of the black race who wanted to get a little notoriety by kicking.  
 The corn boy movement has been raped and railed by the wrecking crew.—Ottawa Sentinel.
