

DIRECTORS ELECTED

For The Country Club On Wednesday Evening

And Plans For Organization Are Discussed

Members To Hold Picnic Early In September

On The Grounds Recently Purchased By The Club

A Complete List Of The Members Up To Date

The wheels of the Mt. Vernon country club were formally set in motion at a stockholders' meeting in the offices of the Mt. Vernon Telephone Co. Wednesday evening, when announcement was made of the incorporation under the laws of the state of Ohio, a code of regulations adopted and directors elected.

The board of directors, nine in number, constitutes the governing body of the club, as is the case in all incorporated organizations. Out of a list of eighteen names submitted by a nominating committee, consisting of Messrs. W. A. Ackerman, H. K. Walker and H. O. Simons, Wednesday evening, the following directors were elected for respective terms: Three years—F. L. Beam, N. R. Eastman, H. C. Devin. Two years—F. O. Levering, R. M. Lamb, W. J. Sperry. One year—E. O. Arnold, I. M. Wolverton, R. C. Ringwalt. On account of the late hour when adjournment was made Wednesday evening, the board of directors determined to postpone organization until Thursday evening at 7:30 o'clock in Mr. H. C. Devin's office.

By the code of rules and regulations, presented by H. C. Devin, of the organization committee, there are five classes of membership: active, associate, junior associate, non-resident and honorary.

Active members are stockholders. The privileges of the club are extended to themselves and families, including all sons under the age of 22 years. The associate membership is unmarried girls above the age of 18 years and widowed ladies. In case of the latter, privileges are extended to families, including sons under the age of nineteen years. Junior associate members are girls between 14 and 18 years of age and men between 19 and 25 years. Privileges in this membership are extended only to the holder. Non-resident members are clergymen and people residing without the county. Honorary membership is limited to one man a year, to be elected by the board of directors.

A share of stock is the initiation fee of an active member, his dues \$20 a year. An initiation fee of \$20 is required of all the associate members with dues of \$20 per year. The junior associate membership is open at a \$15 fee with annual dues of \$15, while non-resident membership is \$10 with \$10 dues.

All applications for membership must be made in writing. The same will be posted for fifteen days on the club bulletin board and the directors will then proceed to elect or reject the applicant. The membership of the active class is limited to 150. A share of stock is non-transferable, but upon expulsion, death or departure of a member must be turned in to the board of directors which will offer it for sale. In case of death, the family of the deceased has first option on the stock.

Each member of the club is allowed to introduce and entertain at the club as many out-of-town guests as he or she may desire. Residents of the county who are non-members of the organization may visit the club five times a year, when introduced by a member. The board of directors is given authority to extend this period in special cases and also to throw open the club grounds to all for one day, should such action be desired.

With the formal incorporation and organization of the club, plans are

being made for a picnic of all members and their families on the site during the first week of the month of September. It is planned to have the picnic at the noon hour, so that the afternoon may be devoted by those who have the leisure, to looking over the grounds. It has also been suggested that a quantity of corn be purchased and the same roasted. On the country club site there is a large quantity of timber which will require some cleaning up. By having a corn roast, a goodly portion of the loose wood could be utilized for the fire.

Nothing will be done in the construction of a club house this fall, but work will be started as early in the spring as possible. In the meantime, the board of directors plans to visit a number of country clubs located in cities the size of Mt. Vernon and secure ideas for a club house.

It is altogether probable that a temporary golf course will be laid out on the site before the summer is over. Professional O'Brien of the Westbrook club of Mansfield will probably be hired for this purpose, so that members may enjoy the game during the fall.

The skin was bruised in several places where the hand-car passed over the lad's body, but there were no cuts. Attending physicians feared that the liver had been injured.

RUN OVER BY HAND CAR

James Estill Meets With Very Serious Injuries

Physician Believes That He Will Recover
