A NEW SPECIAL AGENT FOR EL PASO

PIONEER EL PASOAN DIES IN NEW JERSEY

J. Freudenthal a Mine Operator and Mercantile Organizer.

News has reached El Paso of the death at Towaco, N. J., July 4, of Julius Freudenthal, first business man of early El Paso and pioneer copper mining man of Arizona. Death came a life of 30 years, which left its mark in business monuments of the southwest, notably the Arizona Copper company and the H. Lesinsky company of El Paso.

A native of Germany, Mr. Freudenthal came to New York, and thence almost immediately to New Mexico. That was in 1851. A general mercantile business was established at Belen. A few years later a large business house was established at Las Cruces in association with Charles and Henry Lesinsky.

That firm engaged in extensive mining operations and produced the Longfellow Copper company at Clifton, Ariz., in 1876. In the name of the great New England post, a fancy firm, Freudenthal, the company mined and smelted copper ore. It was the first successful operation of that kind in the territory. Products were sent 700 miles overland, in the absence of railways, and Indian hostility caused an endless source of difficulties. In 1882 the holdings were sold to a foreign syndicate, the Arizona Copper company resulting.

The house of L. B. Freudenthal was established in the early eighties in El Paso, the pioneer being associated with his son, Ludvik, also known to many early settlers of this city. This concern soon became a leading business venture of El Paso, a general mercantile business being transacted. The Freudenthals relinquished their local holding 10 years ago, and the same concern evolved into the H. Lesinsky Co.

Surviving are Ludvik Freudenthal, now a resident of Newark, N. J., and S. J. Freudenthal of El Paso, a nephew, who is secretary and treasurer of the H. Lesinsky company.

Mr. Freudenthal never resided in El Paso for any great length of time. He lived in New York city, making frequent trips west in inspection of his business ventures. Since the sale of the local company he has been almost inactive in business, spending his declining years at his New Jersey country home.

AGENTS OFFERING INSURANCE RELIEF

Refusal of Renewals Proves Not to Be Concerted Action.

El Paso is not to be deprived of all insurance protection by reason of the orders received Monday by a majority of the local agents instructing them to refuse to make renewals on policies expiring on July 31, when the reduced rates promulgated by the state fire rating board went into effect. A few of the local agents have received the amendments from their general agents without any instructions as to the refusal of new business. Until such instructions are received by the El Paso agents, they will continue to accept business from persons having policies expiring after last Monday.

Few Agents Will Benefit.

This will throw practically all of the new business to these few agents who have not been instructed to refuse renewals, as the instructed agents will not dare write any new business in the face of the instructions received. At least three of the local insurance agencies have companies in which the renewals will be written and they state that they will continue to accept all new business until they are instructed by their companies not to accept any further business under the reduced rates.

The Action Not Concerted.

When the instructions were received Monday it was thought the action of the insurance companies in instructing agents to refuse to renew policies was a concerted one and it would be impossible for agents to write any new business on mercantile risks to renew the policies. But since the few local agents have received no such instructions and expect to continue to accept the new business as long as they receive no instructions to the contrary, it is thought that the edge has been taken off of the order which practically deprived El Paso of future fire protection.

Orchards and forage crops being the only ones attempted under the dry farming system.
