



TUCUMCARI GETS TWO INDUSTRIES

Kemey, Sentenced on Burglary Charge, Says Another Man Got the Money.

Tucumcari, N. M., Dec. 19.—Among the new enterprises to locate here is a broom factory, which is being started by Carter Smith of this city, and the Fullwood brothers of Bard City. The plant is to be located at the old well west of town, and will have a daily capacity of 40 dozen brooms. CORRECTS POSSIBLE WRONG IMPRESSION

Pecos Wishes It Known That It Is Not in Pecos County.

Pecos, Texas, Dec. 19.—The Pecos Commercial club has issued a statement calling attention to the fact that the city of Pecos is not in Pecos county. The census returns showed that Pecos county had decreased in population, while Reeves county, in which the city of Pecos is located, made large gains in population. Pecos county's poor showing was due to the cutting off of the county of Terrell from that county, which places much of its population in another county.

The Reeves county school institute is being held today. Teachers from all parts of the county and from the unorganized counties adjacent to Reeves are attending.

O. L. Williams is expected shortly from Dallas to confer with the citizens regarding establishing a beef and pork packery in this city. Mr. Williams represents New York capitalists.

MUST PLANT BEETS AND MORTGAGE LAND

Portales, N. M., Dec. 19.—Promoters of the proposed beet sugar industry in the southwest have visited Portales and have made a proposition to the Commercial club which, if accepted, will mean the erection of a beet sugar factory at a cost of \$1,500,000, with a capacity of 1000 tons of beets a day, using 400 laborers. The proposition provides that the farmers bind themselves to put in so much acreage in beets, to be grown under the supervision of an expert, for 20 years. They must also give a \$50 per acre mortgage on the land used in beet growing, but will receive preferred stock in the factory equal to the amount of the mortgage. The Commercial club will take up the matter with the people on Wednesday.

MUCH BUILDING IS NOW BEING DONE AT TULAROSA.

Tularosa, N. M., Dec. 19.—The work on the Citizens State bank building is going on rapidly. The building will be two stories high, the second floor being designed for lodge room purposes. It will be ready for occupancy about February 1.

Aliaza Hispana Americano lodge No. 41 is making preparations for building a lodge room upon their property, recently purchased in the east portion of town. Stone from the quarry east of town will be used for the foundation.

The foundation for the five room cottage of Grant C. Otis in the west part of town is being laid. A Bailey has been contracted for the carpenter work. Health conditions are improving, but whooping cough continues to prevail.

SPENT OWN MONEY FOR COUNTY ROAD

Now Legislature Must Pass Bill to Allow Money to Be Repaid.

Albuquerque, N. M., Dec. 19.—At a meeting of the Commercial club it developed that Capt. Gillenwater, while road supervisor during the Irrigation congress here in 1908, paid \$12,000 of his own money for the construction of a road from Albuquerque to Tracion park in Old Albuquerque, the county paying \$3000. Now he wants the money, but the county supervisors cannot pay it without a special act of the legislature authorizing them to do so, as under the law they are allowed to pay out money for roads only during the year they are constructed.

Captain Gillenwater has applied to the Commercial club, and the legislature, at its next meeting, will be asked to pass a special act authorizing the payment of the money.

MASS MEETING TO URGE BARRICKMAN TO TAKE JOB

Alpine, Texas, Dec. 19.—A mass meeting of citizens will be held at the court house tonight, at which W. C. Barrickman will be present, and efforts will be made to close a 18 months contract with him to act as booster secretary for Alpine.

M. M. Whisler has bought the house and lot where he conducts his tin and sheet iron works, of G. W. Terry, for \$1200.

W. H. Harding has located three sections of land near the McDaniel range and will move out to his "squat" following the holidays.

Mrs. Alice N. Corwin gave a Christmas tree in her rooms at the W. Brister Phelps home.

John Robert Kennedy died at his home in this place Thursday afternoon of Bright's disease, and was buried yesterday afternoon at 3 o'clock under the auspices of the Woodmen of the World. He was 24 years old.

Great confidence was shown at the meeting of the future growth of Balmorhea and Toyah valley and a movement was set on foot and 250 subscribers guaranteed for a good weekly newspaper at this point.

The executive committee is working with a special committee on the location of the stock yards at some convenient point near town. These yards will be the largest shipping point for range cattle in Texas and the valley is fast becoming the greatest feeding point.

With the completion and operation of the alfalfa mill and mixing plant, large feeding yards are proposed and feed cattle will then be shipped monthly to El Paso and nearby markets supplying a better grade of beef than can now be had.


ON TRANSPORTING COMBUSTIBLES.
