GOMPER'S DEFENDS McNAMARA; CALLS ARREST AN OUTRAGE

Washington, D. C., April 24.—President Samuel Gompers, of the American Federation of Labor, says the arrest of John J. McNamara is an outrageous outrage and attributes it to enemies of organized labor who are plotting money interests to destroy labor unions.

He suggests that the states in the exercise of their police powers as foreign countries, and that no country would think of giving up a citizen on mere demand of another country without a hearing.

NO ARMISTICE YET DECLARE OFFICIALS

Mexico City, Mexico, April 24.—Government officials persisted today in their refusal to admit the existence of an armistice between federal troops and rebels, characterizing yesterday's transactions as merely an exchange of propositions which it is still necessary to study.

No one outside of the official family, however, doubts that armistice is an accomplished fact. According to Capt. Wood, it describes in detail the dynamiting of buildings, railroad trains and factories where conflicts between union and nonunion labor existed. The loss of lives and the destruction of property valued at almost \$2,000,000 is said to be detailed.

The chief of the Chicago detective department said the confession was placed in the possession of attorneys representing the National Erectors' association and has been sent to Los Angeles to be used in the trial of the cases against the men under arrest.

"The confession was made at the home of detective Wood, of the Chicago police, in South Chicago," said Capt. Wood.

McManigal was being watched, returned to Los Angeles with a plan of the explosive said to have been the auxiliary plant in which the Times was being issued. It is said he made several inspections of the plant.

McManigal and McNamara then came on the same train bearing the watchmen. The pair went to Kansas City, to Peoria again, to South Chicago, to Milwaukee and a dozen other points, always carrying a mysterious suitcase, which it was later learned, contained the clockwork basis from which the infernal machines were formed. Finally the pair came to Indianapolis, where the Los Angeles work was done.

John McNamara, the first time he had appeared in any connection with the dynamiting.

First the two visited secretary McNamara's office at night and held a long consultation. The next day McNamara kept an appointment with the two in a street near his office and the three went into another conference at Peoria.

Then McManigal and James McNamara again went to Kansas City and following them watchers found a "plant" arranged under a new bridge across the river at Peoria, Ill., containing a quantity of the nitroglycerine found there on the waters below prevented an explosion.

The Week Terminal. From this time frequent visits were made by the two men to the office of secretary McNamara in Indianapolis, the detectives gaining new evidence and preparing for a "round up."

They followed McManigal to Toledo where he was joined by James McNamara. The two then departed for Detroit, both carrying heavy suitcases. Watchers in Detroit had informed Burns, the detective asserted, that an attempt would be made to wreck the new steel terminal and it was determined to prevent this loss.

Chicago detectives were asked to aid in the arrests and detectives Bidder and Reed were sent.

McNamara and McManigal were arrested by the Chicago men and told that they were wanted for safe blowing. Confident they could prove an alibi on this charge, the men made a light resistance. Their premature disclosure of the fact behind the arrests would complicate proceedings in the arrest of secretary McNamara, who already had been secretly indicted by a Los Angeles grand jury.

The authorities making the prisoners acquainted with the real nature of the charges against them.

A Giveaway Question. On the way to Chicago the man, however, became moody and suspicious and McNamara started the police with the question: "Say, is it for the Los Angeles job you fellows want?"

McNamara related attempts to force a confession from them.

Raymond Burns, son of William J. Burns, said McNamara had offered him \$20,000 and later \$30,000 for the liberation of himself and McManigal. The story of the offered bribe was said to have been heard by the Chicago officers and verified by them.
