COUNTY WANTS TO BEAUTIFY THE VALLEY ROAD; WILL FURNISH TREES

If the People Who Own the Property Along the Road Will Water the Trees, County Officials Agree to Furnish Them and Set Them Out; Makes Road Beautiful; Adds to Value of Land.

For the purpose of beautifying the county roads by planting trees, Judge Elyar and the commissioners are calling on all persons living on these roads to send in their names so that trees can be furnished to them free of charge.

The only duty resting upon the residents is to care for the trees after they have been planted. Half of the trees which were planted along the Ysleta road by the county three years ago are dead, according to the statement of Judge Elyar Monday morning.

"Not quite half the trees, the county planted along the Ysleta road three years ago are now alive," said the judge, "but the ones that have pulled through have many times repaid the county for setting them out."

"The county's plan is to set out the trees for anyone who will take care of them afterward. On this offer, more than two miles of trees were set out along the road below Ysleta last spring. It is rather a difficult matter," continued the judge, "to create enthusiasm for planting trees in the fall or the spring, when trees are barren and leafless, but it seems to me that the kind of those trees along the Ysleta road should impress everyone with the beauty and value they add to the farm they border and adorn, without regard to the pleasure they give to travelers along the road. Add a year or two more to the growth and these trees will make those parts of the Ysleta road, where they have lived, as beautiful as any driveway in the country."

"If the sight of them now should make anyone living along the road want something like that in front of his place, if he turns his request in now, it will be filed away and taken care of at the proper time. It would be much better for him to do this now than wait for the spring."

The strikers gathered about the gates of the mills and made a noisy demonstration, but no violence was reported during the early hours.

Society Girl Among Dead. San Francisco, Calif., July 15.—Mrs. E. G. Pohlmann, who was killed yesterday in the wreck at Hinsdale, formerly Miss Ethel Sherman, a prominent society girl of this city, until her marriage to Edwin G. Pohlmann, of Santa Rosa, eight months ago. She was the daughter of Frank C. Sherer, president of the Carson Courier-Silk company. Her husband is traveling representative of the Illinois Glass company. She was 23 years old.

The couple were on their way to New York to take charge of the body of Pohlmann's father, who was here two weeks ago while en route from Porto Rico, where he owned extensive coffee interests.

Dual Inquiry. A dual inquiry is being made today in an effort to fix the blame for the wreck, one by coroner Hoffman, of Cook county, and the other by the railway commission, at the scene of the wreck, with the officials of the road.

The conduct of three persons, one of which is dead, will be inquired into, in an effort to fix the blame. The acts of George Brown, the engineer of the mail train, who was killed; Mrs. F. A. Wilcox, tower operator, and flagman John Woodruff, of the Overland, are those to be questioned.

Both Mrs. Wilcox and Woodruff have said they did their duty—the former by placing block signals and the latter by placing torpedoes.

Only one thing has been definitely established regarding the cause of the wreck, and that is that a dense fog played a big part in the disaster.

Officials of the Chicago, Burlington & Quincy railroad today began investigation at Aurora, of the cause of the Western Springs, yesterday which resulted in the death of 13 persons. Mrs. F. A. Wilcox, block signal operator at Western Springs, who was killed, declared that his engineer, George Brown, who was killed, was not at fault.

The signals were set for a clear track in the block west of where we struck. We heard the torpedoes and Brown shut off steam and reversed the engine. We were too close to stop. He died like a hero," said Crain.

More identifications made. Positive identification was made today of the bodies of G. W. Moore, of Lacey, Ia., and her daughter, Lois Adol Todd, 4 years old. Three bodies, two women and one little girl remain unidentified at LaGrange.

ONE KILLED IN WRECK ON GREAT NORTHERN

Six Cars Roll Down an Embankment and Burn; Several Injured.

Fargo, N. D., July 15.—One man was killed and several passengers are said to have been injured when the Orient Limited, the Great Northern's fast Pacific coast train was wrecked at Ashby, a small station 74 miles east of here yesterday. Six cars left the train and rolled over an embankment. They took fire and were consumed. They consisted of four coaches, a baggage car and mail car.

William Campbell, whose home is said to be in Minneapolis, was instantly killed, but all other passengers were removed from his cars before the fire started.

The seriously injured are: Mrs. Lilly Allee, said to be from Minneapolis. Mrs. Herman Olman, Sioux City, Iowa.

MINERS ASSEMBLE IN CRIPPLE CREEK

Gilded Key to City Is Given to Western Federation Delegates.

Cripple Creek, Colo., July 15.—Fears of a possible attempt to prevent the holding of the annual convention of the Western Federation of Miners here, because of the bitter feeling following the strike of 1904, proved groundless and the opening session today was marked by the best of feeling. Mayor Joseph Bitterly, in his address, extended a cordial welcome to the delegates, and presented a gilded key to the city to president Charles H. Moyer, who voiced the miners' appreciation of the kindly reception.

A credentials committee was appointed and the convention took a recess until 3 o'clock, when the committee report probably will be approved inasmuch as there are no contests.

The annual address of president Moyer is scheduled for tonight. Among matters to be settled by the convention are, granting to local unions authority to conclude long term contracts with employers and extending the organization to Mexico.

NEGRO AND DOG IN WATER PIPE

Caused Epidemic of Typhoid Fever in a Michigan Town.

Benton Harbor, Mich., July 15.—The body of a negro and his Newfoundland dog, drowned in the St. Joseph river two years ago, are the source of the typhoid epidemic that has been raging here. The state board of health made the discovery during an investigation undertaken after 1,200 people had been afflicted with the disease.

The bodies were found, according to report, beneath the mouth of the intake pipe near the middle of the stream. They are believed to have been drawn there by the suction of the water, probably shortly after the drowning. Several scores have died from typhoid fever since the epidemic started.

The negro and his dog came here with Ringling Bros.' circus. The negro went to the river for a swim between performance and fell from the diving board into the water, being taken with cramps. The faithful dog went to the rescue, but the negro grasped it so tightly that both went to the bottom.

So far as the circus people were concerned, no effort was made to recover the bodies. The city authorities made some effort, but failing the negro and dog were soon forgotten. It was reported that the pair had been caught in an undercurrent and carried down the stream.


Then came the typhoid epidemic and, despite all efforts it would not recede. Authorities insisted that the water was pure, but encouraged the people to boil it, which finally aroused some suspicion and the situation was brought to the attention of the state board of health.

RAILROAD NEWS

STATE TO SUE ROAD FOR HEAVY PENALTY

G. H. May Have to Pay \$305,000 For Violating 30 Minute Rule.

Austin, Tex., July 15.—The attorney general's department, on behalf of the state, will this afternoon or tomorrow file in the 33d district court, according to assistant attorney general Robertson, a suit against the Galveston, Harrisburg & San Antonio railway for penalties aggregating \$305,000, charging violations of the 30-minute rule of the commission and running its passenger train between Houston, San Antonio and El Paso behind the schedule time.

The petition is now practically completed and ready for filing. This is the result of an investigation instituted by the commission as to their trains running behind time. The proposed penalty suit against the Katy is also expected to be filed this afternoon.

BRISK RAIN COMES AS SUNDAY FEATURE

With It Is Some Lightning and Telephones Suffer the Most.

A well behaved little rain stormlet made a Sunday afternoon call and made canopy room scores down town. The rain arrived about 3 o'clock and kept on the job long enough to save the north side of the necessity of sprinkling their lawns.
