

SENATORS JUDGE RIBB TO RECLAMATION

WASHINGTON, D. C., June 2.—A fight in behalf of farmers under the reclamation projects of the west and southwest today appeared imminent in the senate. There was a pronounced sentiment that the settlers are in need of a relief measure relative to payments on the various irrigation projects, and a filibuster was threatened.

Among the projects considered to merit close attention are the Elephant Butte, near El Paso, the Roosevelt project which provides for the irrigation of the Salt River valley around Phoenix, and the Laguna project at Tuma, Ariz.

Senators Make Plea.
The matter was brought before the senate today in a plea by senator Borah for public land legislation for the west before the adjournment of congress.

The senator said the west needs a reclamation law and a power law, but he conceded they require much time. Only a few weeks are left, it was urged, to pass a bill for the retention by the settlers of the early payments on reclamation projects.

Jones Proposes Filibuster.
"Four or five years may be a short time for us to legislate, but it is a long time to the settler in the west and southwest who is being forced to pay for this reclamation project without the passage of this law. It will be an act of injustice and inhumanity to the thousands on the projects."

Senator Jones proposed a filibuster to get the reclamation legislation. He said senator Borah added there probably would be no river and harbor bill unless the reclamation was added to it.

REPORTED BLAZE AT SCHOOL FALSE ALARM

About 6:30 o'clock Monday night, after a peal of thunder and a flash of lightning, some one telephoned the central fire station that the Lamar school, corner of Dallas and Montana streets, had been struck by lightning and the roof was on fire. The fire company responded to the alarm but were unable to discover any fire or any place where the school building had been struck.

Child Starts Blaze.
Monday afternoon shortly before 5 o'clock, a little girl with a match set a fire in a room in the Goff hotel, corner of Stanton and Mills streets. The curtains and some bed quilts on a bed near the window were destroyed. The mattress on the bed was also badly damaged.

QUEVEDOS CAUSE HALTING OF WORK

Work of clearing the Cumbre tunnel, repairing the North Western railroad and preparing the Cumbre tunnel, has ceased because of the Quevedo bandits in western Chihuahua. The crews which have been at work clearing the Cumbre tunnel since the tunnel tragedy have all been taken off the track repair crews have been discharged and only necessary watchmen are being kept in the employ of the company at Madera and Pearson. The Quevedos are reported to be at Colonia Garcia, in the Madera district, but have not been molesting settlers in that section.

FRIENDS CONCERNED ABOUT E. PROVENCIO

Friends of E. Provencio, a prominent resident of Juarez, are anxious about his welfare. He left for Chihuahua several days ago and it is feared he has been detained there. Senor Provencio is one of the leading citizens of Juarez and has a number of important positions there and owns much property. A difficulty regarding the payment of a special injunction suit, "Constitutional" government, which occurred recently, has added to the alarm of the Juarez man's friends in that town and in El Paso.

NO DAMAGE REPORTED FROM VOLCANIC OUTBURST

Redding, Calif., June 2.—Thus far no damage has been reported as a result of the eruption of Mount Lassen in Shasta county. Further activity of the old volcano would endanger the timber in the forest and northwest of the peak. On the north side there is no danger of a conflagration as the slope is covered for miles from the summit with lava and there is little vegetation.
Twelve automobile parties started from Redding to try to reach the crater.

CUMMINGS RENOMINATED FOR SENATE BY HEAVY MAJORITY

Des Moines, Ia., June 2.—Senator Albert B. Cummings, Republican, was renominated to the United States senate by a heavy majority ranging from 60-690 to 59,990 over A. C. Savage, according to estimates based on early returns. Congressman Connolly, Democratic candidate for senator, should defeat E. T. Meredith by 38,000.
Governor Clarke's plurality over his two opponents for the Republican nomination for governor was expected to be around 15,000.

Leader Disclaims Political Ambitions, in Statement He Has Issued.

ers point to the deliberations of the commission and the statements of the press as absolutely ignoring this situation. The peace commission even goes so far as to propose that the "Constitutionalists" must recognize whatever provisional government they decide to set up, and to declare that they must be forced to recognize that government or be crushed.
"The Constitutionalists leaders are wondering how they are to be forced to do this in view of their present accomplishment and by whom they are to be crushed if they decline to obey the commission. Calmly, too, the commission proposes that Huerta shall be permitted to be a candidate for the presidency in order merely to save his face. Do they think the Constitutionalists will consent to that any more than they will consent to recognize a provisional government constituted as the commission proposes of one person selected by Huerta, one by the voters, and one perhaps, but not at all likely, by the Constitutionalists?"

Cannot Deal With Huerta.
"No one, the Constitutionalists leaders point out, who has had any acquaintance with the objects and purposes of their movement, would fancy for a single moment that they would ever consent to that they would have anything whatever to do with any one friendly to, or heretofore connected with Huerta. The Constitutionalists make it plain beyond question that they will recognize a government established under the plan of Guadalupe at the triumph of the revolution. According to this plan the commander-in-chief of the Constitutionalists army will be the provisional president of the Mexican republic, who is the alternative being verified and constitutional order is restored to the country. They declare they will tolerate no outside interference with the settlement of the entire process. They declare that if let alone they will settle the entire Mexican problem in a few months, and in proof of their ability to do this point to what they have already accomplished in the way of driving the Huertista from two-thirds of the area of the country with the imminent prospect of securing the other third in the near future."
Villa Disclaims Ambitions.
Gen. Villa's declaration, as given out by the bureau of information at Juarez, said in part:
"I have been informed that our enemies, the men who belong to the party of treachery, are developing intrigues aimed, using my name and exalting my military merits, at the prospect of making me appear with an ambition which I do not possess, for the purpose of establishing divisions and discord among the Constitutionalists. If victory has accompanied me it has been not only because of my own personal courage, but also because of the courage, patriotism and discipline of my companions in arms."
He adds that those who put forward his name for the presidential office without his consent and that he regards them as personal enemies.

RIVAL CUP DEFENDERS RACE FOR FIRST HONORS

Rye, N. Y., June 2.—When the cup races yacht Vanitie and Resolute sailed today for their initial contest in the series for the selection of the American boat to represent the country in the September, there was not enough to flutter the private signals of the men of the sea. The weather was clear, but for several hours before noon the time set for the race off Great Captain's island, the water off the sound shore like the burnished brass sides of the Vanitie.
Much regret was expressed over the inability of the Vanitie to start, as aspirant for cup defending honors, to start today. The Troy city yacht was still undergoing changes in her rig when it was expected would be completed before Saturday.
The official times of the start were: Resolute, 12:45:40.
Resolute won the honors at the start. She slipped over the line nearly 25 seconds ahead of the Vanitie, going fast. The Resolute, owned by the first officers' syndicate of the New York Yacht club, slipped over the line at 12:45:12, 34 seconds a head of the Vanitie.
The weather was ideal. Just before the boats got under way a fresh northeaster of 15 knots wrinkled the surface of the sound, but shortly after the start it had decreased to not more than eight or ten knots.

PEOPLE USED BY ENGLAND TO FALSE SECURITY

Charge Is Made that Government Showed Its Weakness.

should be massacred before they had an opportunity to defend themselves. This plot was all the more heinous because it was made at a time when the government was pretending to be seeking a conciliation, thus lulling the Ulster people into a false state of security. In other words they were to be murdered in their sleep.
After the breakfast on March 11, the cabinet met and decided upon certain military and naval movements in Ulster. That fact stands undisputed. On March 14, Mr. Cullitt, secretary of the army council, wrote a confidential letter to Gen. Sir Arthur Paget, commander-in-chief of the troops in Ireland. This letter, which was subsequently published by the government, said that the government had received reports that attempts might be made "in various parts of Ireland by evil disposed persons to obtain possession of arms, ammunition and other stores." It was, therefore, considered advisable that Gen. Paget should "at once take steps to secure the stores."
On March 19 the cabinet considered the question of removing the stores from Ulster. Sir Arthur Paget decided to order the troops north to guard them. In the meantime Gen. Gough, brigadier in command at Camp Curragh in Ireland, was busy in visit and inspected in his own name and that of nearly 100 other officers against being ordered to "initiate" action in Ulster. The war office, after a cabinet meeting, wrote him that no orders would be given the soldiers except when necessary to protect stores.
Next morning the Ulster men were in great joy. Their newspapers announced "The Army has killed the Home Rule."
Government Weak, Charge.
Unionists glee was measured only by Liberal and Labour and Nationalist anger. The cabinet had decided to order the troops north to guard them. The cabinet had surrendered the power to control the army to a cabal of Liberal and Labour politicians.
It was not believed that the cabinet could last a week longer. John Ward, Labour member of parliament, in which he denounced the king's interference with politics, and he was cheered for half an hour. The king rushed back to London from camp in visit and inspected the premier to set him right with the people. No such critics had ever known in British politics for a century.
And it is interesting to know that on the nights when troops were to be sent into Ulster the Ulster volunteers were mobilized and under arms to receive them.
