EUGENICS was very seriously discussed without gloves Wednesday afternoon at the meeting of the Woman's club. The discussion was held in the parlors of the club. Mrs. Henry Clay Greer discussed hereditary traits in relation to eugenics. The three discussions were received with the greatest interest by the club women. Mrs. Stillwell talked about juvenile immorality, which she attributed to the majority of cases to the children not having been rightly born. "Even in wedlock," she said, "too many children are born, not of love, but of lust, and they inherit immoral tendencies. She spoke of the danger of mothers to present the truth of nature to their children in the right way so that children's first knowledge and impressions should be clean and wholesome, saying that too often the mothers were either too busy or too dense to teach the right way. Consequently the children learn perverted and smutty versions from their playmates or older children and are led to immorality as a result of the wrong idea. As the idea of eugenics can only be accomplished universally by the creation of strong public sentiment, she favored, Mrs. Stillwell asserted that this lay in the power of each woman to train her own children with the right, clean ideas toward life, so that when they come to marry, they will be better able to make their selection of a life partner. She spoke of the danger of women taking the task of guarding some girl.


