Million Coal Miners Will Throw Down Picks Feb. 27

LONDON, Feb. 21.—It isn't without the range of possibilities that someone will have to undertake that proverbially superfluous duty of "bringing coals to Newcastle" if the threatened strike of coal miners is carried into execution. The Newcastle exchange states that there is little or no coal to be had now, for everyone with command of coal is holding for fancy figures. The prices have already advanced so high that the poor have to sit in fireless houses. The great strike of all coal mine workers throughout the United Kingdom, throwing out of work more than a million mine workers, is due to commence Feb. 27. That was assured after the poll of all of the federation miners, some 600,000 men, who voted three-to-one to walk out.

The conciliation board has so far failed to effect a settlement. The men want the minimum wage plan of payment. In Staffordshire, the men demand that they get at least 7 shillings (\$1.68) a day. In South Wales the desired minimum wage is 8 shillings. Of the million workers, 80 per cent work underground. The death by accident rate has risen from 1.29 per 1,000 in 1900 to 1.43 in 1909.

The masters are willing to grant the minimum rate to workers in abnormal places, where death or a crippled life is more apt to be the miners' reward.

"We look like being in for one of the biggest struggles ever known," said James Haslam, a member of parliament, and chief official for the Derbyshire miners. "If there is to be a strike, the million miners will be followed by another million of other industries, and there will be civil war in no time. Nothing like it since the 'seventies will have been seen," he added.

"The proposed system of payment of a fixed minimum rate of wage to each person working in the mines, irrespective of the amount of work performed is one which is quite impracticable and cannot be conceded," said David A. Thomas, managing director of the Cambrian collieries combine, and head of the "masters' organization."


