Householder re-entered the Northwest league last spring as the skipper for the ill-fated Victoria Islanders, and after a stormy course in bossing the job, Eddie gracefully retired. He always was a swell long distance hitter, and Dug figured he would be just the candy to wallop the ball over the crackerbox fence. Eddie was moderately successful in this, and was a tower of strength with the bat, though a trifle slow on his feet. After joining Seattle he was most amiably disposed, but while trying to fight his way to the top with the Islanders Householder had some cantankerous sessions on the diamond.
