VICE PROBE SURPRISE! REV. A. D. SHAW QUILTS SOCIAL SERVICE BOARD

CALL A GRAND JURY

If Prosecuting Attorney Remann is sincere in his desire to clean up D street, he will call a grand jury.

Without it he will be poorly equipped for the task.

The mere temporary closing of the doors of a few brothels will be laudable, but far from satisfying.

What the people of Tacoma want, in addition, is a thoroughgoing renovation of the police department. Until it is accomplished the renovation of D street can be but temporary.

Charges that the police are crooked have been openly made during the last week. Remann has been considered as friendly to the police administration. That he is so, The Times does not charge. The Times does suggest, however, that for him to call a grand jury to investigate the allegations will be his best refutation, his best earnest of sincerity.

Furthermore, Mr. Remann, the people will not tolerate your placing the burden of obtaining proof in the redlight cases on the citizens' committees. These organizations no doubt will be delighted to co-operate with you the minute they are convinced you mean business. They may not wish to turn over to you their evidence until they are assured that you will use it in real prosecution.

Another surprise in the Tacoma vice probe came today when the Rev. A. D. Shaw, pastor of the First Congregational church and a member of the social service board, tendered his resignation to Mayor Fawcett.

The note accompanying Rev. Shaw's resignation was dated last Saturday, and the document specified that the pastor's duties as a member of the board had ended on the night of March 20. The note contained only a formal resignation, with a brief expression of good wishes to the mayor.

Rev. Shaw's resignation is believed to have resulted directly from conclusions expressed in his interview in The Times Friday night, in which the minister declared himself disgusted with the police method of handling vice in Tacoma.

Refuses to Talk.
The resigned board member refused utterly today to announce his reason for quitting.

Rev. J. A. Sutton of the First Baptist church, one of the prominent members of the social service board, who threatened last week to resign, refused to make a statement today.

He intimated that his resignation would be sent soon to the mayor, but refused to make any public statement. Rev. E. C. Bloomquist, the third man mem-

ber of the board, is out of the city.

Surprise to Mayor.
Rumors at the city hall of a general split and resignation of the social service board are growing stronger. Charges have been made that the police department has refused to co-operate with the board in its efforts to clean up vice in Tacoma.

"I was distinctly surprised to hear that Rev. Shaw had resigned," said Mayor Fawcett today. "He sent me his police star, and completely severed his relations with the board, but gave no reason. Rev. Shaw has not been under fire, and I thought that he was just beginning to get well interested in his work."

Other members of the social service board are Rev. R. H. McGinnis, W. F. Jurisch, Mrs. C. S. Bowie, Mrs. S. A. Crandall, Mrs. Leonard Craswell, Mrs. J. A. Hayes, Mrs. Ida W. Healey, Commissioner Mills and Mayor Fawcett.

Railroad Man Is Shot and Robbed

Marshal James Hughes of Tenino notified the Tacoma police Monday that Scott Blair, a railroad man, had been shot down in the Tenino railroad yards last night and robbed of \$20. Blair was seriously wounded. The thugs are believed to have started toward Tacoma.

DISTRICT ALREADY DONS HAT

Prosecutor Remann personally investigated immoral houses on D street Saturday night with the result, he said today, that he found the district comparatively free of women.

"In one house where I positively know 10 women were inmates a few nights ago, I found but two Saturday night, and these two had their hats on ready to make a get-away," he said. "However, I have the names of former inmates for use when the case comes to trial."

Says Owners Protest.
Many property owners, Remann said today, had come to him indignantly protesting against their places being investigated and assuring him that no vestige of vice might be found on their premises.

Remann said he knew nothing of internal affairs in the police department. He would not commit himself as to whether he believed Mayor Fawcett's recent charges of graft founded on reasonable grounds, but said he intended giving the police a chance to work hand in hand with him in the vice cleanup.

To File One Suit Soon.
"If I find any indication that I am being double-crossed, however, or that there is a reluctance on the part of the public safety department to make arrests when

the time comes, I shall drop the police and depend solely upon my own resources," he declared.

Remann expects to file his first abatement suit some time this week. It will be directed against the owner of a hotel which has been raided three times within a month, he said.

The two women returned last night from Portland, where they established their identity to the legal representatives of the Bell estate and their right of inheritance.

Each will receive a sixth share of an estate which is estimated at \$3,000,000.

The new fortune will make not the slightest change in the mode of living of the Hoyts, so Dr. Hoyt said today. Both he and his wife are agreed that he is to continue his profession, and that they are to live, as now, in their present home in Tacoma.

John K. Bell was an uncle of all of them.
