(United Press Leased Wire.) BERLIN, via wireless to Saville, L. I., Nov. 1.--Repulse of British troops north of the Somme were announced by the war office today.

"The weather is growing brighter on the Somme district and on several sectors lively artillery activity has begun," said the official statement.

A supplementary statement declared that artillery activity was strong only north of the Somme, and added that Fort Vaux temporarily came under heavy fire of French guns on the northeastern front of Verdun.
