COMMUNITY CLUB TO GET RETURNS NOV. 2

Will Hear Election Results From All Over Country At Big Meeting at High School Tuesday Night

Telegraphic returns of the results of the state and national election will be received Tuesday evening at the big meeting of the Lynden Community Club at the Lynden High School. A direct connection with the Western Union wires will bring in the news, and will give those present the first-hand information on how the battle is going.

In addition to this feature, a lively program has been arranged to keep the crowd amused in between bulletins. A basketball game will be staged between the High School team and the Lynden City Five, members of the county league. Other athletic events are included in the program, together with musical numbers and contests and sports of all kinds. Special election-night refreshments are being provided by the committee, so that the evening will be interesting from all standpoints.

All those who have enrolled in the club since its organization are urged to be on hand, together with those who would like to join. Any citizen of the district is eligible to membership in the club.

THE BIG ISSUE ON TUESDAY

Adoption of a program of State Socialism, or its defeat, will be the leading issue before the voters of Washington at the polls Tuesday.

The Farmer-Labor Party Platform declares specifically for the public ownership program advocated for years by the Socialist party.

As the strongest of the Anti-Socialism groups in the field this year, the Republican Party should receive the concentrated support of Democrats and Republicans at the polls Tuesday. Party must be forgotten in the state campaign! Hadley, Hart, Coyle and the rest of the state set should receive a solid vote.

BURY THE CARLYON REFERENDUM!

Whatcom County alone paid in \$100,319 in automobile license fees to the state since March 1, 1920. Of this sum, the county gets back about \$10,000 for its road work.

If Whatcom County could have its license fees for its own use, the annual four mill road and bridge tax could be abolished in this county. This big \$100,000 fund, under the Carlyon bill, would be drained out of the county for the next twenty years.

A \$30,000,000 bond issue with \$12,000,000 in interest, is a poor business plan, when it is considered that state road funds now total \$5,000,000 annually. In six years, were it considered desirable to hard-surface the Carlyon system of trunk line roads, this work could be accomplished under the pay-as-we-go plan!

Vote against Referendum No. 1, the Carlyon bill!

ENDORSE THE BONUS FOR OUR SOLDIERS

The Lynden district should give a unanimous vote in favor of Referendum No. 2, the Soldier's Bonus Measure. For the sacrifices that our boys made, the bonus is an insignificant return. Let's give them this small fund with a 100% vote Tuesday!

CITY DUMPING GROUND NOW READY FOR USE

Bridge Completed at New Municipal Dump; Insurance Official Warns City To Clean Up

Completion of a bridge across the city garbage dump was announced this week, and dumping will be permitted now at the municipal grounds.

The marshal has been instructed by the council to allow no dumping at any other part of the city, in accordance with the local ordinance, now that the city dump is ready.

The dumping grounds may be reached by going north on Eighth St. from West Main. Dumping will be permitted off the bridge on the grounds only.

That Lynden must clean up or the insurance rates will be raised, is the message left here this week by a representative of the State Insurance Department. The business houses, especially, he declared, are keeping their alleys and premises in a disgraceful condition.

NOTED KANSAS MAN TO SPEAK HERE TONIGHT

Ex-Congressman Charles F. Scott To Deliver Address at Republican Rally in I. O. O. F. Hall Tonight

Charles S. Scott, former congressman from Kansas, one of the most eloquent of the speakers sent out by the national committee, will address a Republican meeting in Lynden tonight at the I. O. O. F. Hall. Delegations will be present from all parts of the county to hear Congressman Scott, as this will be the only meeting that he will address in the county. He will come directly to Lynden from Portland, Oregon.

Mr. Scott will discuss the issues of the campaign, and will tell of conditions in his home state and throughout the East.

A feature of the meeting will be the music, which will be furnished by a band of fourteen pieces from Bellingham.

FOUR MEASURES UP BEFORE VOTERS NOV. 2

Carlyon Bill, Soldier's Bonus, and Two Constitutional Amendments Must Be Passed Upon

Two referendums and two constitutional amendments must be passed upon by the voters of Lynden at the polls on Tuesday.

Referendum No. 1 is the Carlyon bill, a measure providing for the construction of a state system of hard surface highways, financed by the issuance of \$30,000,000 in bonds.

Referendum No. 2 is the soldier's bonus bill, providing for the payment to veterans of the war with the Central Allied Powers, the sum of \$15 for each and every month or major fraction thereof of active duty performed subsequent to April 6, 1917, and prior to November 11, 1919.

These payments are to be provided by the sale of \$11,000,000 in bonds. Amendment No. 1 to the State Constitution provides that private property may be taken by the state for land reclamation and settlement purposes. It is important that the Reclamation Board be given this authority, for without it land that is required for reclamation or land settlement purposes may be held at such exorbitant prices that the completion of a project will be delayed and possibly defeated. This amendment gives to the state the same rights that railroads enjoy—the right of eminent domain.

The second amendment to the constitution of the State provides for raising the salary of state officers to the following scale: Governor, ten thousand dollars; lieutenant governor, two thousand five hundred dollars; secretary of state, five thousand dollars; treasurer, five thousand dollars; auditor, five thousand dollars; attorney general, six thousand dollars; superintendent of public instruction, five thousand dollars.
