Awarded First Place in the Inter-scholastic League.

ASSOCIATION IN GOOD SHAPE.

Deputy Insurance Commissioner J. H. Snavely reports.

Spokane, Wash., May 22, 1905. Hon. Sam H. Nichols, Secy. State, Ex-officio Ins. Com.—Dear Sir:—In response to an invitation of the Pacific Live Stock Association, of the state of Washington, I visited the home office of this association, under current date, for the purpose of examining into its condition of affairs.

I find the association under the management of the following gentlemen: E. R. Ward, Pres.; W. J. Walker, Vice Pres.; W. H. Hunter, Secy.; P. H. Hilliker, Gen. Mgr., and J. B. Schrock, Treas. George Farnsworth is associated with these gentlemen in the executive management.

I very carefully examined the books of the Pacific Live Stock Association, and find them to be carefully kept, and that the affairs of the association are very conservatively and economically managed.

The number of risks written to date is 1054, aggregating 725,000 on insurance. The largest risk being \$1000. The premiums received to date amount to \$59,000, and the losses of the company have been promptly paid and there is no liability of this character against the association.

The gentlemen managing the affairs of the association are highly spoken of by the business men of the city. I take special pleasure in recommending to you, the association, as it is the only company of the kind which is authorized to transact this kind of business, by the insurance department of Washington.

I am under the impression that insurance is being written on the Live Stock resident in this state, by non-resident associations, which is in direct violation of the laws of this state, and does not give the protection that the farmers have a right to expect.

I have watched the operations of the Pacific Live Stock Association, from its inception and discover a very earnest desire on the part of its officers to comply with all the laws of the state. They are not only worthy of the patronage of the residents of the state, but deserve to be protected from the illegal operations of outside companies, and the only way in which I think relief can be given them, is by means of a public statement of this character, to the effect that this association is the only one authorized to transact this character of business, by the insurance department as before mentioned.

Ordinance No. 313.

An Ordinance amending Section One of Ordinance No. 156 entitled, "An Ordinance defining and establishing the fire limits and regulating the erection of buildings so as to insure safety from fire" approved June 8, 1893, and repealing Ordinance No. 193.

The City Council of the City of Colfax do ordain as follows:

SECTION I.

That Section one of Ordinance No. 156, entitled an Ordinance defining and establishing the fire limits and regulating the erection of buildings so as to insure safety from fire, approved June 8, 1893, be and the same is hereby amended, so that said section shall read as follows, to-wit: All that portion of the City of Colfax included within the following boundaries is hereby declared to constitute and be within the fire limits of said city, to-wit: Commencing at the intersection of Brewery street with the South Palouse river, thence east on Brewery street to the alley in the blocks lying between Main and Mill streets, thence north along said alley to Upton street, thence west along Upton street to South Palouse river, thence southerly along said river to the place of beginning.

SECTION II.

Ordinance No 193 is hereby repealed.

SECTION III.

This Ordinance shall take effect and be in force six days after its passage, approval and publication. Passed May 15, 1905. Approved May 16, 1905.
