Pot Pourri of News Selected Mostly From Exchanges.

Joe Sluder has 12 acres of ground under wire fencing at Farmington and will engage in the poultry business on a large scale.

The Pullman Commercial Club has decided to put up its own building and a committee has been appointed to start the work. Present plans contemplate a two-story brick building with dimensions of 200x150 feet, having store rooms below and club, lodge and office rooms upstairs.

The schedules for the two new short courses which the Washington State College is offering for the first time this winter have been issued. One course, known as the domestic science group, is designed for the large number of farmers' wives who are expected to accompany their husbands to the winter school this coming year and is another step in the movement the college has undertaken to better conditions on the farm. The second new course is for the benefit of the large number of foresters in the Inland Empire or those interested in forestry, timber cruising or lumbering.

With the purpose in view of erecting a building especially for gymnasium purposes the Palouse High school has started a gymnasium fund.

It is estimated that nearly 100 carloads of apples were shipped from Farmington this season.

Pullman grain buyers estimate that 35 to 40 per cent of the crop is still in the hands of the farmers, being held for the higher price expected in the spring.

A. J. Harris, an old pioneer, who has resided in this country for 30 years, was found dead in his bed last Friday morning. He had been suffering from rheumatism.

Engineers are at work surveying the Sunnyside tract, which is one of the assets of the defunct Palouse State bank, having been held by the Palouse Loan & Investment company, a holding company for the bank, says the Palouse Republic. The land is to be platted in 10-acre tracts and will be put on the market in January, probably being sold at public auction.

What is known as the half mile trestle on the Milwaukee railroad near Rosalia is to be replaced by a ground road bed. The large tunnel which recently caved in, necessitating the building of a temporary road around the hill, is to be opened into a railroad cut and the ground from this used to fill in the trestle. The trestle is the largest on the Milwaukee road, and is considered one of its most dangerous places for traffic. Two men have been electrocuted on this trestle recently and several have been severely injured.
