

COMMODITIES HOLDING UP WELL

Hay Market Remains Quiet, with Prices Even a Little Lower Than Quoted Last Week—Live Stock Lower.

Markets in all lines have been notably featureless during the past ten days, and the slight change noted in a few particulars has been toward lower prices. Alfalfa hay, for example, is not eagerly sought after by the dealers, and the top price is \$7.25 delivered.

Produce is no higher than last week, and in some cases is lower. It takes the fanciest kind of a spud to bring \$15 a ton now, although this price has been paid for a few lots during the past week.

Onions are still high in price, and getting scarcer. One firm paid \$38 a ton for a pretty fair lot Monday, and none have sold for some time past for less than that price.

Poultry is quoted lower, and geese, ducks, old hens and spring chickens all roost on the same perch, so to speak, and for the first time this winter are all quoted at the same price—8c a pound.
