WHITE SLAVE'S STORY A PICTURE FROM HELL

BERTHA CLAICHE, IN HER CELL, TELLS HOW THE SOULS AND BODIES OF BLOND-WOMEN ARE SOLD IN THESE UNITED STATES.

Sin-Goaded French Girl Who Shot Gerdron, Her Owner and Destroyer, Glories in Her Act Because She is Free of the Fear She Held for Him—A Club of Such Monsters in New York—Club Women Are Working on Case

NEW YORK, July 27.—It is a curious travesty that it should fall to the lot of a white slave, a poor childlike-minded French girl, to arouse the storm of public sentiment against the unspeakable traffic of the Gerdron vultures which has followed in the wake of the arrest of Bertha

Claiche for the murder of her brutal master. Her emancipation led her to a Tombs cell, with the blood of her victim upon her hands. She says that is better, far better, than the life he forced her to lead. The three bullets which ended his loathsome life have done more than the poor, sin-goaded girl dreamed of as she plotted her crime. Those three ringing shots have put into motion a wave of sentiment, nationwide, which may end the reign of the human wolves who prey upon unfortunate women wherever society has cast them out. The girl who is lying in the gray Tombs, awaiting the verdict of 12 of her peers for her crime against a statute law, shot down Emile Gerdron, who at that very moment was on his way to a police station in the custody of two detectives, charged with brutally beating this girl, for years his abject slave, and who even then bore the blue marks of his savagery. Then came the pitiful story of the girl. She is a weak, childlike-minded little creature, who covers

and a fierce black mustache. He fascinated me. He followed me home. He talked nice to me and told me I was very pretty, which made me like him a little. He said he would be my friend and after a few weeks he said that he would marry me and we would go away off to America where we could live in happiness and he would make much money. "I believed him and trusted. My mother would not listen to our plan. Then we ran away. He brought me to New York. I asked him to keep his promise and marry me. He laughed and told me that people did not get married in America. Then he became harsh and cruel and I was very much afraid of him. One day he struck me in the face. Then I trembled all of the time. I was afraid he would kill me. "He turned me out on the street at night and told me to bring him money. When I did not bring enough he would beat me with his fists until I wanted to die. Some times I would bring him \$5. Then he would pound me and tell me that he would choke me to death if I did not bring more. When I brought \$10 he would not say much, but he would treat me kindly if I brought him more. "He took all. He bought me what I ate and the few clothes I had to wear. He wore the finest clothes and went to fine hotels and restaurants and bet his money at the race tracks. He drank wine all of the time. "It was about a year ago that I discovered that Gerdron had other white slaves. He abused them, too. His men associates were doing just the same. There are many of them in New York. They have a club. "I tried to get away from him many times. But he knew always where I would go, and he said he would kill me. I was afraid. I told the police that I was afraid and showed them the marks where he had beaten me. On the night that he arrested him I went to identify him in a crowd. When he cried out before them all that he would kill me for what I had done, I knew that he would carry out his threat, so I took a pistol from my dress and killed him. O, Gerdron, you are dead and I am glad!"

The girl fairly glories in her act. She does not weep. Her father and mother, the former ill, came to New York a few months ago to attempt her rescue. They failed because she feared death at the hands of her master. Stirred by the story of this unfortunate girl and by the revelation of this horrifying condition, several hundred women have banded themselves together to raise a fund with which he may be defended in the courts and be saved from paying the penalty of death in the electric chair at Sing Sing. Several women's clubs have taken interest in the case and are using all of their influence to stir the police to action to stamp out the hideous evil of the Gerdron vultures. Mrs. Charlotte Smith, president of the Women's Rescue League, in a letter to the French ambassador, asked that the French government take some action in behalf of her defense.

COMMANDER YOUNG A MAN OF NERVE AND NARROW ESCAPES

TOOK A LINE ASHORE FROM SINKING SHIP IN A HURRICANE AND SAVED THE CREW OF THE SLOOP-OF-WAR HURON.

Stood on His Deck Amid a Rain of Bullets From Spanish Gunboats—Refused to Fall Down the American Flag at Honolulu—When He Fell Into Havana Harbor.

By Gilson Gardner. Staff Correspondence to The Press. WASHINGTON, July 27.—Commander Lucien Young, who was ashore at the time the explosion occurred on the Bennington in San Diego harbor, has had his share of hair-breadth escapes.

The one which is best remembered, although it occurred many years ago, was in connection with the wreck of the Huron. That was in the early '70s and Young was only a junior officer.

One evening in the late fall the old sloop of war Huron put out from the harbor of Norfolk. It is said that she was not in condition to get to sea, and it is whispered about the navy department that some of the officers had dined too freely of their judgment would have been better; but that was a long time ago, and the navy is full of gossip.

The fact remains that she put to sea in the face of threatening weather and with boilers which soon showed themselves inadequate to cope with the stress and strain of a northeast gale. In the course of the evening it became apparent that the boilers were not making steam, and before 10 o'clock the engines were

quite helpless and the ship was drifting. By this time the Huron had made way down the coast of North Carolina to a point near Kitty Hawk and the northwest storm had developed into a hurricane before which the ship was driving helpless upon the breakers.

It was then that Lucien Young and a boatswain mate responded to a call for volunteers to man the life line. Taking a "balsa," which is a species of light float made for work in the surf, and the life line connecting with the ship, they sprang into the sea and swam for the shore. It was a fight for their lives and for that of the crew. After what seemed an eternity to the swimmers, they reached the shore, more dead than alive.

The insurgents had deposed Queen Liliuokalani and had raised the American flag at Honolulu. Their American war vessels had arrived in the harbor under the command of Admiral Erwin. The latter ordered Young to go ashore and haul down the flag. Young declined. He told his superior officer that he would submit gladly to court-martial, but he never would have it said of him that he hauled down his country's flag. He was not court-martialed. After the Spanish war Commander Young was made captain of the port of Havana and while stationed there had an escape which is not chronicled in the official records. He was returning to his vessel in the harbor one evening, after a day in town. As he was about to mount the ladder from his small boat, being a heavy man and the light not very good, he swayed backward and plunged head-first into the waters of Havana harbor. His bullies caught him by the heels as he went down and pulled him back into the tender.
