JAPANESE IN INTERESTING ENTERTAINMENT

Music of a weird sort was played on Japanese mandolins and guitars, singing, and dancing was interspersed throughout the athletic stunts.

DESPERADO CAPTURED AT EUGENE, OREGON

PORTLAND, April 7.—Jack Mitchell, accused in five states of horse stealing, train robbery and the murder of two deputy sheriffs, and who has repeatedly declared that he would never be taken alive, was captured at Eugene and brought here this morning. He will be taken to Idaho for trial on the charge of murder. He robbed the Northern Pacific train in Montana two years ago and killed one of a posse who was searching for him. Next he was hunted for horse stealing in Idaho where he killed his pursuers.

DOWIE LEAVES MEXICAN SOIL

(Scripps News Association.) LAREDO, Texas, April 7.—John Alexander Dowie entered the U. S. this morning, but not in a private car because none was available. When the train stopped at the International bridge for inspection, a crowd of newspaper men were met at the car door by Dowie's associates who would not permit close contact with the "prophet." They said Dowie's strength is increased under the recent opposition. Dowie, after the train left Laredo welcomed The Press correspondent. He denied entirely the charges of his wife, son and the overseers that he had said he would drive his son and wife 'from the city of God.' He says he has been true to every trust and is answerable only to God and that "the charges are the foul mouthings of ingrate curs." The receivership and curtailing of his commands are illegal acts. Women may have proved the downfall of the prophets of old, but they cast no spell upon modern prophets. "They say that I lost millions in Wall street. It is a lie. The lustful letters purported to have been written by me are forgeries, and the creators shall be in prison and their charges be publicly refuted. "Within a week I, Elijah Dowie, will again be Zion's leader and accepted as the holy man of God, and not a charlatan."

The buggy was in need of repair and Carroll took it back to the Novelty Works to have it fixed up. He was told that the rig was stolen, and he hastened to the police station to report the matter. As he proceeded to give a description of the thief Sergeant Dial's eyes opened wide. Carroll was describing the bicycle thief that for a long time has baffled the police. It was only the other day that he stole a bicycle from the Coeur d'Alene lodging house. He came there in the evening and paid \$2 for a week's room rent. He stayed long enough to steal a bicycle. Later the police recovered the wheel of a Main street second hand dealer.

Mrs. Maud A. King of Chicago, has been awarded \$1,000,000 of the King estate.


The Christian Herald has collected \$25,000 additional for the starving Japs. Total is now \$150,000.

DONNELLY FUNERAL SUNDAY AFTERNOON

Father Verhagen will officiate at the burial of Ed Donnelly, set for 2 o'clock Sunday afternoon, from the parlors of Smith & Co. Donnelly is the 19 year old boy who while in the act of robbing the Spokane Cloak & Suit House was shot by Detective Briley. At first it was decided to bury Donnelly in the potter's field, but Con Crowley undertook to bury the dead boy after a Christian manner.

Mrs. A. Douville of 514 Jaffa street, Lidgerwood, has established beyond a doubt that Donnelly is her second cousin. Before he died Donnelly said he was from Deer Lodge, Wis. Mrs. Douville is from Shell Lake, in that state, and she communicated with the police back there and learned the relationship. Numerous people have viewed the remains, many being women. Yesterday another beautiful gift of flowers was placed on Donnelly's coffin by an unknown woman. The police department has in cus-

ody Robert Duffy and Frank Kelly, two chums of Donnelly, whom they believe were instrumental in sending Donnelly into the store and to his subsequent death. It is the opinion of the police that Donnelly was only the tool of the older men, who, finding he was bold and fearless, sent him into the store to ascertain the lay of things and report back to them later. It was while under the influence of liquor Donnelly undertook the job and was discovered and shot. Duffy, one of those in custody, told the police that Donnelly comes of good parentage, his father being a well to do shingle manufacturer.

PENSION ORDINANCE WILL BE INTRODUCED.

City Commissioner John Grey has prepared his pension ordinance and will submit it to the city council at its meeting Tuesday night. It is a proposition to pension all city employes with half pay after they have served the city continuously for 20 years. Mr. Grey first undertook the matter for a pension for the policemen but its scope will be extended and it will apply in all departments. Detective F. Helin, of the Minneapolis police, talked entertainingly on the subject last night at the police station and told of the system in vogue in Minnesota. He says the state law there pensions police officers who are over 55 years, old at \$40 a month and it requires 20 years service.

COUNTY PHYSICIAN GUILTY OF NEGLECT

AN INVESTIGATION OF THE CONDUCT OF DR. MORRISON DEMANDED — VIOLATES HIS OATH AND FAILS TO PERFORM DUTY THAT ANY REPUTABLE MEMBER OF THE MEDICAL PROFESSION WOULD BE ONLY TOO GLAD TO ASSIST IN.

An investigation of the conduct and evident malicious neglect of duty of County Physician W. F. Morrison is demanded by the people of this city. That he is guilty of neglect there can be no doubt and according to more than one complaint that has been lodged with The Press his inattention to duty has reached a point where it is time to call a halt.

Surely no better illustration of the criminal neglect of a county official has ever come to the notice of a newspaper than that of Mrs. Knuckle, a penniless woman, who, after being cared for at the detention hospital for several days, was removed to the home of A. E. Lambert, E329 Riverside, because of the arrival of a patient with contagious disease at the hospital. Mrs. Knuckle was about to become a mother, and Mrs. Lambert was told by the authorities that the woman would be cared for during her illness.

In speaking of the matter this morning, A. E. Lambert said: "I called Dr. Morrison on the telephone and told him of the woman's predicament but he refused to attend her. My wife was in ill health at the time and not competent to care for so serious a case, and a

day or two later I again called upon the county physician and informed him that without he attended the woman immediately that I would prosecute him. This seemed to frighten him a little for he called at the house. After merely looking at the woman as she lay in bed he turned with the remark: 'She does not need my help any more than a cat needs nine tails,' and started toward the door. I halted him and in a few words as possible informed him that he must do something at once to relieve the woman's suffering. He again looked at her and said he would return to the house in two hours.

"That was the last we saw of him. My wife and myself did the best we could to alleviate the woman's suffering and for hours watched at her bedside while waiting for the official physician of the county to return. When the critical time came he was not present nor did he even telephone so that we might have been able to secure another doctor. We were alone in the house, and each minute seemed to be the last of the poor woman, but by careful attention and the assistance we were able to give her, she lived. The baby was born and Mrs. Knuckle is doing nicely, but it is not the fault of Dr. Morrison that she lives."

Other cases have come to the notice of The Press, and this paper will continue to tell the public how he violates his oath as an officer of the people and a representative of the medical profession.

If there is not an investigation made of Morrison's conduct by the proper authorities of the county it is the duty of the local Medical society to take action.

MINER KILLED

BURKE, Idaho, April 7.—David Taylor, a prominent mine and mill man, was caught by a belt in the Hercules mill and killed this morning.

TAKES OPTION

The treasury stock of the Star Mining company, owning a group northwest of the Morning, near Mullan, Idaho, is in option to A. B. Campbell, the millionaire mining man of Spokane. Mr. Campbell has taken an option on 445,000 shares and has paid \$50,000 down. He has also made arrangements with Austin Corbin, J. A. Finch, I. N. Payton and D. F. Moffatt to take in their stock. Mr. Campbell expects to develop the mine further.

PIRATES ROB MISSIONARY

(Scripps News Association.) HONGKONG, April 7.—Dr. Chas. K. Hager, an American missionary, was robbed April 3 by Chinese pirates who held up three passenger boats while anchored in Tung river. They were attacked by 40 pirates armed with Mausers. The boats were riddled with bullets and the cash, clothes and surgical instruments taken from Dr. Hager.
