## BUSINESS CHANGE IS BEING MADE

PART OF LARGE STOCK  
IS TO BE CLOSED OUT

F. E. Livengood to Become Sole Proprietor of the Ready to Wear and Drygoods Department of Big Store—Men's Furnishing Goods to be Closed Out—Building Rented.

According to T. C. Taylor, president of the F. E. Livengood company, the advertised closing of sale of the men's furnishing goods department of the big department store is to be a real closing out. The First National bank, the principal owner of the store, has found an opportunity to go out of the general merchandising business and as it was practically forced into it in the first place, the opportunity has been seized.

According to present plans the men's furnishing department of the store is to be closed out and in accordance with this plan that half of the big building has already been rented. As the new renter desires to take possession January 1, it will be necessary to close out the present stock before that date.

The other side of the store, that containing the ready to wear and dry goods department, will be taken over by F. E. Livengood, the present manager of the company. Taylor says Livengood is now making arrangements to take over this department of the store and he has no doubt but that the deal will be consummated. According to the president of the company, the manager not only has the confidence of the banks and outside financial interests but also of the general public.

It will thus be seen that the big sale which starts tomorrow is not due to lack of success but simply to the fact that the bank has seized the opportunity to let go of the store which was acquired in the efforts to make the bidders for the bankrupt stock of the Teutsch store pay what the stock

stand until the first day of October, 1909, modified as follows:

That the defendants use a sufficient quantity of water to protect and keep the flume and penstock from injury by drouth, and the use of the engine; and in case there be an excess of water in the river over and above the desires and needs of the plaintiffs for domestic purposes, watering stock and irrigation, during the remainder of September, defendants will be allowed to use the same. After the first of October the injunction order will be suspended until the further order of the court, except that the defendants will not be permitted to use or prevent the plaintiffs from using sufficient quantity of water for domestic purposes and water live stock.

The volume for domestic and stock watering purposes will be divided. The use for engine will be subject to domestic and stock watering purposes.

### FEAR ATTEMPT TO DESTROY BRITISH SHIPS

London, Sept. 3.—Following the discovery of high explosives in Bunkers crack battleship "Forward" the admiralty is in a state of ferment. The discovery came in the midst of a rigid investigation after finding explosives in three other battleships recently. As a result of the findings every commander has been ordered to overhaul his vessel for explosives. It is feared there is a systematic attempt to destroy the best British ships.

### MURDEROUS NEGROES VICTIMS OF LYNCHING BEE

Malcom, Ala., Sept. 3.—After storming the county jail a mob lynched Joshua and Lewis Balaam at a nearby tree, and riddled their bodies with bullets. The negroes confessed to the murder of Sheriff J. L. Wainwright. After shooting the sheriff, they literally hacked his body to pieces.

### FRENCH DIRGIBLE STARTS ON LONG TRIP

Paris, Sept. 3.—The army's dirgible airship, "Republique," sailed from Paris today for La Palisse, 240 miles southward in charge of Captain Bols, with a crew and three passengers. They intend to return without alighting if possible.

### Faithful Dog Guards Corpse.

Everett, Wash., Sept. 1.—The body of Joseph R. Schuster of Edmonds was found in the woods near that place yesterday, with his faithful dog, almost famished, guarding. Schuster, who was 55 years old and had been drinking, disappeared August 24 and had evidently gone to the woods and committed suicide by shooting himself in the mouth with a rifle.

### Suicide in California.

Modesto, Cal., Sept. 2.—Mrs. L. C. Walters, wife of a farmer living near Oakdale, committed suicide today by drowning herself in the watering trough on the ranch. No other member of the family was at home and when the husband returned he found the body floating in the trough as he drove up to water his team.

### Champion Cyclist Killed.

Boston, Sept. 2.—Hugh McLean, champion bicycle rider of the world, died tonight from a compound fracture of the skull, suffered this afternoon at the cycle track in Revere, where he was practicing for a twenty mile race with Elmer Collins on Saturday night.

### AMERICAN FLAG GREET'S COOK

During August and September he had a terrific struggle against starvation, and freezing, and finally reached Cape Sparto where musk-ox, bear and wolves killed with bow and arrow, supplied food and renewed strength. Through October, November, December and January 1909, he continued his journey under circumstances seemingly rendering further advance impossible. On February 18 Cook became definitely aware of his whereabouts and started eastward by south toward the base of supplies at Annatask near Etah. On April 15th he arrived at Annataska just eight days less than a year since he left the pole.

On May 21st he reached Upernivik, the Danish settlement, on the west coast of Greenland, and boarded the Hans Egede for this last journey homeward. On Sept. 1st, from Lerwick, Shetland, he announced his discovery of the pole to the world. Only two Eskimos of the remaining party share the glory of his return. They are E. Estukashook, and Aswelab. On Sept. 4th he will reach Copenhagen to be welcomed by the King and Queen.

### NORTH POLE IS OURS BY RIGHT OF DISCOVERY

Washington, Sept. 3.—Dr. Hannis Taylor, an authority on international law stated that in his opinion the United States can now claim ownership to the North Pole by right of Cook's discovery. Admitting such a move will be without a precedent until the discovery is verified, he said the principles recognized in the discovery of land could now be applied to the polar regions. When asked whether the government could claim the thirty thousand square miles of land Cook claims to have discovered Assistant Secretary of State McAtee said: "It is a question that will undoubtedly come up before the law officers of the department. It is a question whether the government cares to claim the land in the vicinity of the pole."

### Belgian Press is Pleased.

Brussels, Sept. 3.—Belgium newspapers comment with enthusiasm on Dr. Cook's achievement. They recall how he came to join the Belgian expedition to the south pole. On the very day the doctor was notified to join the party he cabled from New York asking if by any chance there was a place vacant aboard the Belgica. Instructions were immediately sent to him to join the ship at Rio Janeiro.

Dr. Cook's assistance on the expedition was most valuable, not only as a physician, but as a photographer and scientist. He was the life of the party and worked wonders in cheering up the Belgians time after time when their courage failed.

settlers, especially during the first two years of settlement.

2. That the provision regarding residence upon land under the project be relaxed so as to give more latitude than at present.

3. That the granting of patents to desert claims be hastened so as to permit of the disposal and development of land included under desert claims.

At the session held in the hall following the return of the party from the reservoir these recommendations were discussed to some extent and numerous questions were asked of settlers by Chairman Carter. At the opening of the meeting a brief discussion of the reclamation work was made by Senator Carter who dwelt particularly upon the point that the committee desired to give a ready ear to any complaints there might be regarding the service.

In behalf of the waterusers' association President Irvin then handed a copy of the association's recommendations to the clerk of the committee and briefly explained how the recommendations had been drafted.

Following the presentation of the written recommendations various subjects in connection with the farming of the project were taken up and in the same Col. H. G. Newport, Fred Yates and H. T. Irvin spoke in behalf of the settlers.

### Praise for Service.

Asked by the committee chairman as to how the people regarded the reclamation service and the men in the service Col. Newport replied: "I don't think any of them ever stole a dollar. The reclamation men have been very civil in dealing with the settlers and I believe they have been honest and conscientious in their work. I think they have done everything that men could have done towards making the project a success."

However, Col. Newport offered one criticism of the service officials; the criticism that they have employed some outside labor when they could have secured men who were living upon the project and engaged in reclaiming land.

At the conclusion of the inquiry, the other members of the official party were called upon. Senator Carter expressed regret over the inability of Senator Chamberlain to be present and then introduced Senator Paynter of Kentucky. Following him, Senator Warren of Wyoming spoke and then Senator Jones of Washington.

Director Newell spoke for a few minutes and after further remarks by Chairman Carter the meeting adjourned.

### Party Entertained.

From 7:30 until 8:30 in the evening the visitors were pleasantly entertained at the home of H. T. Irvin, a home that shows in a beautiful manner something of what can be accomplished by irrigation in the west end of this county. The reception was attended by the senatorial party, reclamation and railway officials, the visiting delegation from Pendleton and many Hermistonians.

### Stopped for an Hour.

On the eastbound trip the party was accompanied to this city by the local delegation which went to Hermiston in the forenoon for the purpose of meeting the party and showing Pendleton's interest in the work upon the project.

During the afternoon a message from Leon Cohen inviting the party to stop in Pendleton was received and it was accepted. At the depot the visitors were met by a party composed of Mr. Cohen, Mayor E. J. Murphy, R. Alexander, W. L. Thompson, C. E. Roosevelt, Judge Thomas Fitz Gerald and others.

The entire party then repaired to the rooms of the Wenhatch club, where an hour was passed very pleasantly. Shortly before 12 o'clock the local men escorted the distinguished visitors to the depot and the special pulled out for the east with Nampa, Idaho as the next stopping place.

### COOK ACCORDS HIS FIRST INTERVIEW

Skagen, Denmark, Sept. 3.—Dr. Cook when interviewed by a correspondent who went aboard from the pilot steamer said: "I took daily observations before reaching and after leaving the pole. I was unable to measure sea depths as I had no instruments. The lowest temperature recorded was 117 Fahrenheit."
