

ELECTION PRECINCTS 1900

CENTRAL RIDGE PRECINCT. Commencing at a point where the south line of sec 26, tp 35 north of r 1 E B M, intersects and crosses Little Canyon; thence down Little Canyon to a point where an east and west line running through the center of tp 36 n r 1 E B M, crosses said canyon thence west on said line to intersection of Big Canyon, thence up Big Canyon to where said canyon crosses Boise meridian, thence south on Boise meridian to nw corner of sec 31, tp 35 n of r 1 E B M; thence east along south line of sec's 30, 29, 28, 27 and 26, tp 35 n of r 1 E B M to place of beginning. Polling place: School house in school district No. 41. Registrar, B F Bashor.

COLD SPRINGS PRECINCT. Commencing on the tp line between tp's 34 and 35 n of r 2 W at the N W corner of sec 3, thence due east on said tp line to a point where it intersects and crosses Big Canyon; thence up Big Canyon to a point where said canyon crosses the south line of sec 13, tp 34 n of r 2 W; thence east to the S E corner of sec 16, thence due north to the S E corner of sec 16, same tp and range; thence due east along sec lines to the intersection of Little Canyon; thence down Little Canyon to place of beginning.
