STATE OF MARYLAND. EXECUTIVE DEPARTMENT. PROCLAMATION.

Whereas by the Constitution of Maryland article 14, section 1, providing for amendments to the Constitution, it is made the duty of the Governor to present to the Legislature any bill proposing amendments as therein directed.

AN ACT to amend section five of article four of the Constitution of this State. Section 1. Be it enacted by the General Assembly of Maryland, that three-fifths of all the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Approved April 10, 1889. Section 2. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 3. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 4. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 5. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 6. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 7. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 8. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 9. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 10. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 11. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 15. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.

Section 16. After the election for Judges as herein provided, a three-fifths vote of the members of the two Houses concurring, that the following section be, and the same is hereby proposed as an amendment to the constitution of this State, and if adopted by the legal and qualified voters thereof as herein provided, it shall supersede and stand in the place and instead of section five of article four of said constitution.
