**MURDER AND SUICIDE.**

**Prominent New Yorker Kills Woman and Himself.**

New York, Sept. 3.—Henry Townsend Edson, son of Franklin Edson, formerly mayor of New York City, in his apartments at 292 West Ninety-second street, Wednesday shot and instantly killed Mrs. Fannie Pullen of 673 West End avenue and then shot and killed himself. The murder and suicide appear to have been premeditated and followed a dramatic scene in which Edson asked Mrs. Pullen, a close and honored friend of his wife and family, to desert her husband and children and fly with him to another state. Mrs. Pullen was a beautiful woman and is said to have been the daughter of a United States naval officer. The tragedy brought out the fact that Edson, who was comptroller of St. Michael's Protestant Episcopal church, had been suspected of misappropriating funds belonging to the parish, and that expert accountants were at work on his accounts. It was also declared by those related to the family that Edson was financially distressed because of Wall street speculations.

**TRESTLE COLLAPSES.**

**Six Persons Killed in Wreck on the Southern Railway.**

Charlotte, N. C., Sept. 4.—Six persons were killed and six fatally injured and two seriously in a wreck on the Southern railway near Yorkville, S. C. The dead are: Engineer Briskman, Fireman Frederick, Postal Clerk Hindeman, and three unknown negroes. The injured are: J. Juskeeman, W. J. Usker, and L. N. Hicks. In addition, nineteen white persons and three negro residents of South Carolina towns were bruised, but not seriously hurt. The wreck was caused by the collapse of a trestle forty feet high over Fishing creek.

**MANY LIVES ARE LOST.**

**Hurricane Totally Destroys San Miguel, Oldest Town in Mexico.**

New Orleans, Sept. 8.—Steamship advices of the destruction by a hurricane of San Miguel, a town on the east coast of Yucatan, were received during the day. Not a building was left standing. The steamer Breakwater, which passed San Miguel on her way from New Orleans to Belize, found the place in ruins, not a living being in sight. San Miguel was the oldest town in Mexico. It was the place where Cortez landed when he discovered Mexico, and there he established his headquarters. The hurricane caused immense damage along the Mexican coast and many lives are reported lost.

**JAIL RIOTERS CONVICTED.**

**Twelve of the Fourteen Defendants Will Go to Prison.**

Danville, Ill., Sept. 7.—The main case against the Danville jail rioters went to the jury at 6 o'clock p. m., and a verdict was returned at 11:40. Twelve of the fourteen defendants were convicted. The punishment is an indeterminate sentence in the penitentiary. The case is said to be the first one in Illinois where any one was sent to the penitentiary for endeavoring to break into a jail.

**Two Men Try to Kill the Mayor of Tuscola, Ill.**

Tuscola, Ill., Sept. 7.—Two men attempted to assassinate Mayor McMasters as he was putting up his horse in the barn. The two men attacked Mayor McMasters with paving bricks, felling him twice with blows on the head. One blow was struck from behind. The mayor fought off the assailants and they fled.

Springer, N. M., Sept. 8.—Mine No. 1 of the Dawson Fuel company caught fire and is now burning. In room No. 3 of the mine were Shapiro Ragel and Miguel Zalazar, both of Mexico, and a negro, known as Phil, all of whom perished.
