## --NO. 34--

**An Ordinance to Authorize and Direct the Issuance of Bonds to The Pierz Railway Company to Aid in the Construction of a Railroad from a Point on the Soo Railway to the Village of Pierz.**

WHEREAS The Pierz Railway Company made to this village a proposition duly executed stating that it desired the village of Pierz to issue its bonds for Five Thousand Five Hundred Dollars (\$5,500.00) to aid in the construction of a railroad from a point on the Soo Railway to and through the village of Pierz, such bonds to be payable twenty (20) years from date thereof and to bear interest at the rate of five (5) per cent per annum; the railway company to issue to the village of Pierz such number of shares of capital stock as will at par value of such stock correspond with the principal sum of said bonds, namely eleven hundred (1,100) shares; the bonds above mentioned and the certificate of stock to be exchanged therefor to be deposited in escrow with the First National Bank of Little Falls, the bonds to be delivered to the Pierz Railway Company and the stock to be delivered to the village of Pierz when said railroad shall have been completed ready for the passage of cars from a point on the Soo Railway to and through the village of Pierz, and

WHEREAS, pursuant to law a special election of the legal voters of the village of Pierz was duly called and held at the village hall in said village October 7, 1909, between the hours of 10 o'clock in the forenoon and 4 o'clock in the afternoon to vote upon said proposition, and

WHEREAS, the certified statement of the canvassers at such election shows the mutual agreement for the issuance of such bonds by the village of Pierz and of such stock by the Pierz Railway Company as provided by law was duly arrived at and perfected, The village Council of the village of Pierz do ordain as follows:

I.  
That the proper officers be and they hereby are authorized and directed to issue to the Pierz Railway Company Five Thousand Five Hundred Dollars (\$5,500.00) in and of the bonds of the village of Pierz, executed in such form as required by law, in denominations of Five Hundred Dollars (\$500.00) each, and each bearing date April 1, 1910, and bearing interest at the rate of five (5) per cent per annum, payable annually; the said bonds and a certificate for eleven hundred (1,100) shares of the capital stock of the Pierz Railway Company issued to the village of Pierz to be deposited in escrow with the First National Bank of Little Falls, the bonds to be delivered to the Pierz Railway Company and the stock to be delivered to the village of Pierz when the railroad described in the proposition and mutual agreement above mentioned shall have been completed for the passage of cars from the Soo Railway to and through the village of Pierz.

The said bonds are to be issued under and pursuant to the mutual agreement between the village of Pierz and the Pierz Railway Company arrived at and perfected at the special election duly called and held October 7, 1909, as above set forth, as provided for and authorized by chapter 106 general laws of 1877 and Acts Amendatory Thereto.

II.  
That the notice and calling of the special election above mentioned and the various proceedings, and each and every one of them, in calling and conducting such special election and arriving at and perfecting the mutual agreement above mentioned is hereby fully and in all things ratified and confirmed.

## --NO. 35--

**An Ordinance Granting to the Pierz Railway Company the Right to Construct, Maintain and Operate Railway Tracks Over, Across, and Along Certain Streets in the Village of Pierz, Minnesota.**

The village council of the village of Pierz, Minnesota, do ordain as follows:

Section I. That permission and authority is hereby given and granted to the Pierz Railway Company, its assigns and successors, to construct, lay, maintain and operate a single track of railway of standard gauge, together with all necessary turnouts, spurs and cross-overs, from a point where Koch street intersects the southerly corporation line of said village, along and upon the westerly side of said Koch street in a northerly direction to and across Church street and over and across any and all streets intersecting said Koch street. Also along and upon the westerly side of Bergenhausen street from the southerly terminus thereof in a northerly direction to and across Sixth street and over and across any and all streets intersecting said Bergenhausen street.

Section II. This ordinance shall take effect and be in force from and after its passage.
