GOVERNOR JOHN BURKE

OF NORTH DAKOTA TO SPEAK AT COURT HOUSE WEDNESDAY MORNING

Governor John Burke of North Dakota will speak on the issues of the day from a democratic standpoint at the court house Wednesday, October 3, at eleven o'clock in the morning. The governor, who has been elected to office three consecutive times in the strong republican state of North Dakota, and who received a flattering vote for the democratic nomination for vice president at Baltimore, is a man thoroughly acquainted with the subject to be discussed and a good speaker. All who possibly can should hear his message. If possible to make arrangements, he will make a short talk at the Pine Tree mills.

Governor Burke speaks at Fergus Falls the 7th, at Staples the noon of the 8th, at Brainerd the evening of the 8th, at Little Falls at 11 o'clock on the 9th and at St. Cloud the evening of the 9th. It is possible that W. J. Bryan may speak here on Friday, October 11, on his way from Fargo to St. Paul, but this has not yet been decided on.

A PROSPEROUS FARMER

Robert G. Gruber, one of Pierz's big farmers, was in the city Tuesday and stated to a Herald representative that he had the day before sold Mr. Noggle, the Royaltan cattle buyer, a bunch of cattle worth \$1,150, to be delivered in Pierz in a week. Mr. Gruber, who raises grade short-horn stock, sells a lot of beef cattle and other live stock every year. While he believes in dairying and sells quite a quantity of cream, he says that on account of help on the farm, he can handle the beef cattle to better advantage.

His potatoes yielded 230 bushels to the acre this year.

Mr. Gruber came to Pierz in 1878, starting in a small way, and today is the possessor of 1,100 acres of fine land located about 1 1/2 miles from Pierz in the best county in the country, together with his home, farm buildings and fine stock.

Mr. Kiewel, who was driving the car, cannot account for the accident, as he says that he does not remember going down the hill or over the bridge nor does he know anything of what happened until he came to, and that he must have fell asleep or had a fainting spell.

Mr. Kiewel received a gash on the scalp and Mr. Kronbeck a badly lacerated lip. The front axle of the car was badly twisted and the windshield was broken. A team of horses was procured to pull the car onto the road and they managed to run the car to town.

WANTED FOR FORGERY

H. FLEMING, A CARPENTER, CHARGED WITH FORGING J. K. MARTIN'S SIGNATURE

Henry Fleming, who has been doing carpenter work in this city, is wanted for the alleged forgery of J. K. Martin's signature on checks which he had cashed by several local proprietors of thirt parlor in this city Saturday evening. The checks were for \$20 each and were made out to H. Fleming and signed with the name of J. K. Martin.

Three of the forged checks were brought to the First National bank of which Mr. Martin is cashier, Monday and were immediately detected by the receiving teller. The other forgery was taken to the Merchants State Bank and was not discovered to be a forgery until taken to the First National Bank. Mr. Martin was in St. Paul at the time.

The checks were cashed by Frank Bourassa, LaFond & Smith, T. J. Monahan and F. D. DeBlanc. Mr. Fleming is a married man and has several children and took the family with him, evidently leaving Sunday morning. His whereabouts are unknown but he will undoubtedly be located in a short time.

JURY FINISHES WORK

WLUDARSKA JURY DISAGREES—LEMANIZIK CONVICTED—COURT CASES BEING HEARD

Work was begun on the court cases Thursday morning and the cases will be disposed of quickly.

The jury completed its work on Wednesday afternoon and the petit jury was discharged Thursday morning at 9 o'clock.

The jury that acted in the case of the State vs. John Wludarska, a stabbing affair, was called in by the judge at 5 o'clock Wednesday afternoon and the case was continued over until the March term of court, after a sitting of 36 hours, because of the failure to come to an agreement.

In the case of the State vs. George Olson, in which Olson is charged with selling cattle for Maier Bros. of Pierz and keeping the money, a demurrer interposed by the defendant was sustained and the case was certified by the district court to be determined by the supreme court.

The case of J. Hendrickson vs. Morrison county was taken under advisement by the court. The ditch for which the assessment was levied was enjoined and is not in use.

In the case of the State vs. H. E. Mann, a verdict charging the defendant with assault in the third degree was brought in by the jury. A fine of \$75 and costs was imposed on the defendant and a stay until the next term was granted upon bonds covering the payment, being furnished. Mann is charged with striking A. Fierabend on the head with a poker in a quarrel at the Lincoln depot.

The jury reached a verdict of guilty in the case of the State vs. Paul Lemanezek in which the defendant is charged with selling liquor to a minor and of violating the Sunday closing law. As the sentence is to some extent unusual, and to show the feeling of the court in these cases, we print the sentence given Lemanezek by Judge Taylor in full. It follows:

"It is adjudged and determined that the defendant, Paul Lemanezek, as a penalty for the crime of selling intoxicating liquor to a minor of which he has been duly convicted by the verdict of a jury pay a fine in the sum of seventy-five dollars together with the costs of prosecution; these costs to be taxed by the clerk; these fees and costs to be paid within ten days from this date; and that he be committed to the county jail for the period of ninety days. And it is further ordered that in the event that these fees and costs are paid within ten days from this date, execution of the sentence of commitment be stayed until the first day of the general term of this court now appointed to be held in September, 1913; that will be of one year; on condition that the defendant avoid all infractions of the liquor laws. At any time that it comes to my notice that you have violated the liquor laws in any manner, either by selling at forbidden hours, or to forbidden persons, or in any other way, this stay will be revoked, and you committed to jail. There will be no trial about it, and if you wish to avoid serving jail sentence it will be necessary for you to conduct your place in such a manner that no complaints are made about it, for just as sure as complaints are made about the manner in which you conduct your business just so surely will you go to jail. You are also responsible for the management of your place in your absence, and it does not make any difference whether you violate the law in person, or somebody else in charge of it; not only yourself, but anybody operating the place in your absence; you must have the place so operated that there are no complaints."

A money judgment was ordered drawn up against Alex. Trzebiatowski, who was found guilty of being the father of the child of Pauline Smuda.

In the case of the State vs. Fred Anderson, the defendant was found guilty of obstructing the public highway in the town of Cushing and was fined \$5 and costs with the stipulation that in default of payment he should be committed to the county jail.

The cases which are to be tried by the court are the case of R. Tedford vs. The Northern Pacific Railroad, an action for recovering the loss on wool shipped on the road; State of Minnesota vs. The Pine Tree Lumber company, an answer in a personal property tax case; Ira W. Bouck, as Trustee vs. John Schwartz and Lizzie Schwartz, an action to set aside conveyances as given in fault of creditors: Emma Bachmann vs. Fredrick W. Bachmann, in the matter of the application of William C. Foster to register the title to lot 2, section 5, township 132, range 29, Morrison county, Alfred Green vs. Stainslaus Nagorski, et al; George W. Stewart vs. Nettie Mary Rhodes, et al, an action to quiet title on real estate; Martha Nichols vs. George Nichols, a divorce case; Joseph Wimmer vs. Jos. Wimmer, Jr., Paulina Wimmer and F. Sezepurek, an action to establish a lost deed; Edward G. McLagan vs. First National Bank of Motley, a cor., an action to quiet title on real estate; school district No. 117, Morrison County vs. School District No. 33 of Morrison Co., an action to recover money from the treasurer of the defendant district. A demurrer was imposed by the defendant to the plaintiff's complaint and the argument was submitted.

The case of Ira W. Bouck as Trustee vs. John Schwartz and Lizzie Schwartz was taken under advisement by the court.

The evidence in the case of Emma Bachmann vs. Fredrick W. Bachmann was heard and up to press time was not disposed of.

The case of Mrs. Gertrude Newman vs. The Northern Pacific Railroad company, in which the plaintiff claims that

COUNCIL MET MONDAY

GRANTED RENEWAL OF LIQUOR LICENSE TO LaFOND & SMITH—TRANSACTION OTHER BUSINESS

The application of LaFond & Smith for the renewal of their liquor license was granted with Al. Simonet and Sam LaFond as sureties at Monday evening's adjourned meeting of the council at which Aldermen Kiewel, Lane, Loucks, C. E. Gordon and Koslosky were present.

The bill of Chief of Police Courtlotte for a ticket purchased for Mrs. Clark and son to a point in Michigan was allowed.

The application of Lucas Schrieber to excavate the street on lot 1, block 53, Thayer's addition, for the purpose of fixing the sewer was granted with the stipulation that the work be placed in the hands of a licensed plumber, who is to see that the proper precautions are taken in order to insure safety to the public traveling at night.

A communication from the Water Power company stated that hydrants on Third street northeast, which the council had asked to be put in June 18, was ready for use. One of the hydrants is located on the corner of First avenue and Third street northeast and the other on the corner of Second avenue and Third street northeast.

The communication from E. J. Richie acting for the committee consisting of L. M. Roberts, R. D. Musser, S. C. Vasily and himself, which was appointed at the last meeting of the library board to ask the council to have the library painted and to have a cement sidewalk built on the north side of the building on First avenue northeast, was filed with the city clerk.

The putting in of a new gutter from the American house to the Y block was discussed but no action was taken on the matter. The gutter at that place is in wretched condition and a new gutter is undoubtedly needed as the one there now is in such condition that it will not allow the water to circulate.

Fred H. Hoffman, who has been with a land company in St. Paul for a number of years, will soon leave for California, where he will make his future home.

R. L. DONOVAN INJURED

FORMER LITTLE FALLS RESIDENT VICTIM OF PAINFUL ACCIDENT

Raymond L. Donovan, formerly of this city, was the victim of a very painful and serious accident a few weeks ago in which he had his arm broken and dislocated, several ribs broken and some of the bones in his leg broken.

Mr. Donovan, who is the manager of a large farm near Austin, was riding horseback to Oakland, where he had several teams hauling tile, and the horse was going at a good rate of speed when she tumbled and fell. Mr. Donovan succeeded in getting his feet out of the stirrups and put his arm out to help himself up when the horse rolled on his arm breaking and dislocating it. While he was lying there he kicked him in the side, breaking several ribs. Furthermore in an attempt to roll over, the horse rolled on Mr. Donovan's leg and broke several bones in the ankle.

Mr. Donovan will very likely be laid up for several weeks and may have a crooked arm as a result of the accident.

MODERN WAREHOUSE

COCHRANE COMPANY WAREHOUSE NEARS COMPLETION—IS FROST PROOF

The new Cochrane potato warehouse will be ready for potatoes Saturday and the building will have been completed by the middle of next week. It will be practically a frost proof building 40x60 feet, with a full size basement 8 feet high, cement floor, hollow walls, consisting of an 18 inch wall, 4 inch air space and a 4 inch brick wall. The basement will be studded and sheeted with matched lumber. The main floor has 12 foot posts; double floor, the top one of maple; sheeted on the outside with matched fencing, paper and drop siding; inside with paper and matched fencing; the roof consists of one thickness of paper; two layers of boards and an air space and is covered with roofing.
