BOND ISSUE DELAYED

LIBERTY BOND CAMPAIGN POSTPONED TO APRIL 15—COUNTY QUOTA \$430,000

Owing to the inability to get the supplies out in time, the third Liberty loan, which was scheduled to begin tomorrow, has been postponed to April 15 and will last for five days, concluding on April 20.

Morrison county's quota of this loan will be \$430,000, or about eight per cent more than the last loan. The total amount of this issue will be three billion dollars and all oversubscription.

As yet it is not known how long the bonds will run but it is known that they will bear 4 1/2 per cent interest, an increase of 1/4 per cent over the last issue.

The America First association, which is thoroughly organized throughout this county, will conduct the drive, and it is hoped that Morrison county will go over the top.

From now until the day the drive opens there will be loyalty and bond boosting meetings throughout the entire county. In a number of places in the county meetings have already been held and they have been well attended.
