The great program of reconstruction and living things before us today—which means so much to church and country, is simply another word for social service, because it is the reconstruction and rebuilding of the things which have been demolished, devastated, the reconstruction of man and woman, which is social service. We have got to get together to make a new world out of the fragments of the past, which have remained throughout the storm of war and strife."

Mr. Vassaly told interestingly of existing reform measures and told of the work being accomplished in training schools of the state, speaking of temptations which beset the young men and women of today, he said that while cities are commonly regarded as the chief harbors of vice, and degeneracy, rural districts of the state are not by any means free from the same.

At the morning session, a brief address, before calling upon Msgr. Plichta, of Royaltown, for a report of the financial affairs of the new orphanage. Rt. Rev. Bishop Buech spoke of the need of widespread relief from the standpoint of religious, mental, moral and business needs. Adherence to the laws of religion as sanctioned by the Saviour, he said, alone can accomplish right and acceptance of those tenets must be financial faithfulness.

City Attorney Vernon, in speaking of the opinion of the assistant attorney general, stated he believed that the opinion is correct and is the same as he gave the city council here at the time the paving question was first brought up. Mr. Vernon at that time called the attention of Mr. McGarry and Mr. Babcock to this defect in the then proposed constitutional amendment and urged them to change same so as to include a refund to municipalities directly.

The twelve or more municipalities involved will be affected to the extent of about \$600,000 and Little Falls alone will be affected to an amount of about \$28,000.
